KASLO AREA CLAMS

During May 1966, I examined a Silver-Lead-Zinc showing in the Kaslo Mining District on behalf of F H P Explorations Ltd.

There are 12 claims in the block known as:

Norm 1 to 4 incl.
Norm 5 to 12 incl.

8638 to 8641 incl. 8666 to 8673 incl.

The main showing is on the claim known as Norm No. 4.

The claims can be reached by road and car ferry and lie a distance of 22 miles from Nelson, British Columbia.

Generally speaking the mineralized occurrence appears to be a replacement lens in a limestone formation. A trench and semi-adit have been sunk on the showing and reveal a highly mineralized lead-zinc body ranging up to six feet in width and occurring over a depth of about three feet in the adit face with well developed calcite above and below the mineralization.

The lens strikes north 30 degrees east and has a dip of 42 degrees westerly. It occurs in a strongly developed limestone formation and could not be successfully traced in either strike direction.

It is more than likely that the occurrence is a lens or a pod which has resulted from local concentration of mineral solutions. It is, however, impossible to ascertain on the present showing how much continuity the body may have along the dip.

Assays taken over an 18" width in the hanging wall returned the following values:

Silver	31.3	ounces to the ton
Lead	38.65	percent
Zinc	24. 13	percent

while the adjoining $4 \frac{1}{2}$ showed:

Silver	22.4	ounces to the ton
Lead	25.65	percent
Zinc	20.98	percent

the latter sample being in a heavy gossan zone.

It would be advisable to carry our further investigation on this showing. Extension of the adit and the sinking of a pit down the dip would soon reveal the extent of the mineralization. A sum not exceeding \$2,000 would be justified to either establish or discredit the zone. Recovery of ore could feasibly pay for the operation.
