PROPERTY FILE

Dear Sirs:

This report is based on a visit made to the
Mulvey Creek property on 26 November,
1967.

SUMMARY:

The Mulvey Creek property consists of four located claims situated two miles southwest of Slocan and readily accessible by road.

Little is known of the geology except in general terms. A random sample showed a trace of silver.

It is recommended that a geologic examination of the property be made when the snow is gone and that soil samples be taken on a 500-foot grid.

The estimated cost for this work is \$1,500.

LOCATION:

The property is located immediately south of Mulvey Creek and about two miles southwest of Slocan. The elevation is about 2,000 feet. Map 4.

The geographic location is 49°44'N, 117°29'W. The area is covered by Sheet 82 F 11 W of the National Topographic System.

The claims are readily accessible by road from Slocan. The road through the property is a logging road in good condition.

TOPOGRAPHY:

The topography is mountainous and heavily wooded with small spruce trees. Most of it is covered with overburden. Mulvey Creek flows easterly across the northern portion.

CLIMATE:

The climate is moderate. The winter snowfall is light and severe cold is unusual.

GEOLOGY:

A mantle of snow prevented a thorough geologic appraisal on the writer's visit. Only exposures along the roadside and creek could be examined. Much of the following geologic description is based on information obtained from Geological Survey of Canada Memoir 308, by H.W. Little.

The claims are located in a large area of paragneiss which forms an anticlyne striking southwesterly. The southern border of this body is about a mile from the property. Rocks of the Nelson Batholith lie to the south and also outcrop about four miles to the north, suggesting that the whole area is underlain by granites at depth.

The rocks are conspicuously layered with light and dark bands. Hand specimens obtained on the property were highly siliceous and contained minute bands of limestone.

The property was staked as a silver property but no silver was observed on the writer's visit. A sample of fresh rock taken from material blasted for a road cut showed a trace of silver.

CONCLUSIONS:

No evaluation of this property can be made at present other than to say that it is geologically favourable for the deposition of metallic minerals from the adjacent batholith and that a random sample showed the presence of silver.

RECOMMENDATIONS:

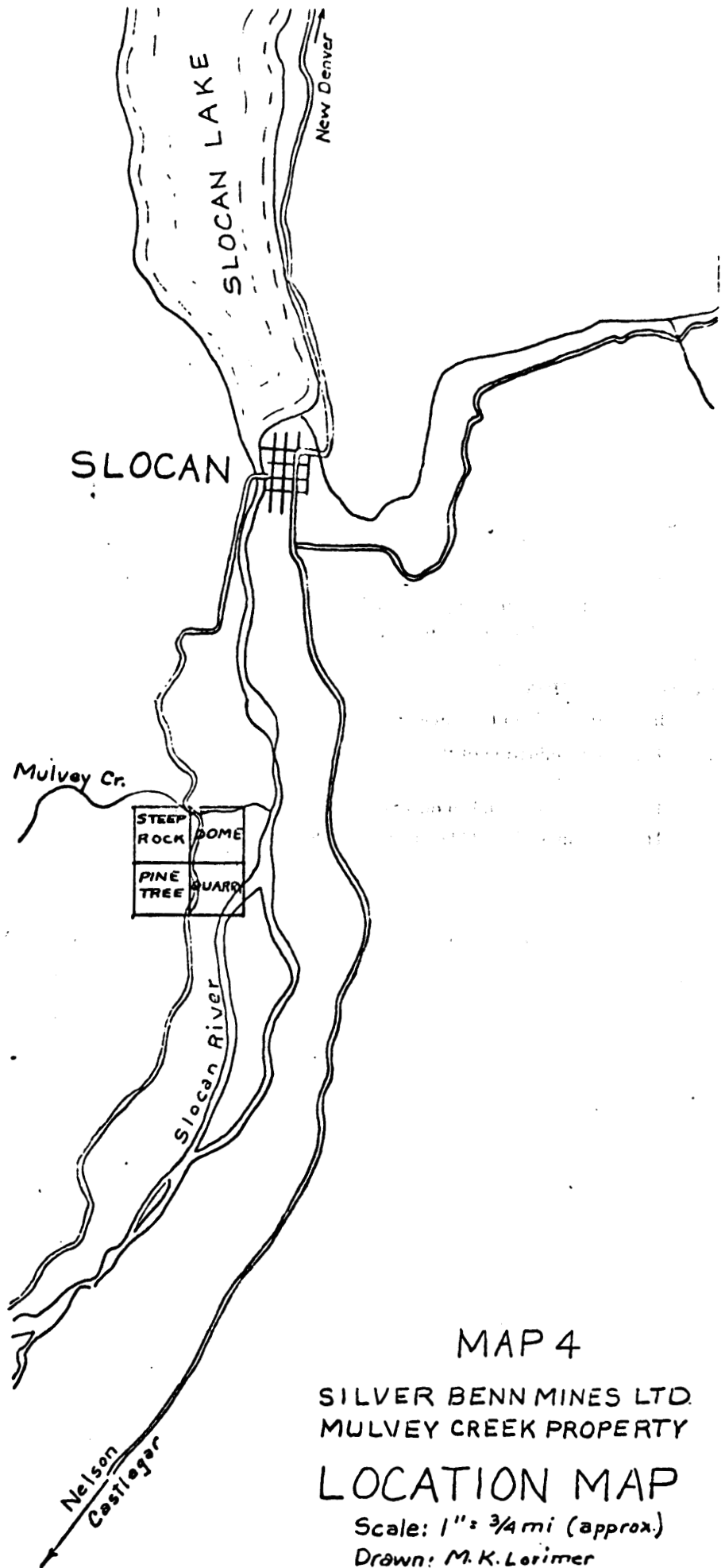
In accordance with the foregoing discussion it is recommended:

1. That an examination of the property be made by a competent geologist or engineer when the ground is free of snow.
2. The soil samples be taken on a 500-foot grid and that the samples be run for silver.
3. That the sum of \$1,500 be made available for this purpose.

MULVEY CREEK GROUP

The Mulvey Creek group is situated approximately three miles southwest of Slocan, and is readily accessible by road. Further, there is a logging road through the property which is in good condition. The company is the recorded owner of the Steep Rock, Dome, Pine Tree and Quarry mineral claims. This group of claims constitutes the Mulvey Creek group and they are held by the Company subject to the provisions of the Mineral Act of the Province of British Columbia. The said claims were acquired from Henry Marasek, Beny Frank Marasek, Sr. of Box 74, Slocan, B.C. and Sally Anne Graboski of 15936-77th Avenue, Edmonton, Alberta, each has an undivided 1/3 interest. The consideration paid to them for the Flathead group and the Mulvey Creek group together was the allotment and issue of 750,000 shares. A total of 69,000 of these shares have now been surrendered to the Company for cancellation, however, until the next general meeting of the shareholders of the company, 750,000 shares are held in escrow by the National Trust Company, Vancouver, B.C. subject to release or transfer only with the written consent of the British Columbia Securities Commission.

So far as the signatories hereto are aware, no other person or company has received a greater than 5% interest in the consideration received by the Vendors of the said claims.

No underground exploration, surface exploration or development work has been done on the said claims to date. At present there is no surface nor underground plant or equipment on the property. For a description of the mineral deposits on the property, see the report of L. J. Manning and Associates Ltd. which is attached hereto and forms part of this prospectus.

The Company has not, to date, carried out any program or exploration or development work on the Mulvey Creek group.
