Material exploration and development work carried out to date, results of same and exploration and development work proposed

Schumaker and Liberal King - no exploration or development work completed to date except for the preparation of geological reports compiled by W.C. Day, B.Sc., P.Geol. dated August, 1988 recommending an initial program for the Schumaker including geochemistry and geophyics to define the graphitic hanging wall contact zone for surface drilling. An initial drill program consisting of 5 short (60 m each) holes is recommended to test target areas. For Liberal King, it is recommended that a grid over the claim area be established and geochemical sampling with concurrent magnetometer and VLF-EM surveys is conducted.

Gold Cup Group - comprised of a contiguous area covering some 830 hectares and containing 4 claims being reverted crown grants and two unit blocks of 20 and 12 units respectively and lie within the Ymir gold camp located in southeastern British Columbia, some 6 Km north Ymir and 15 Km south of Nelson

Property has evidence of gold mineralization in veins and old workings and could indicate a good potential for vein continuity on strike and for parallel veins

Three phase program recommended to establish baselines for areas, complete a soil orientation, map and sample existing workings and outcrops. Second phase, which is success contingent of the first phase will investigate anomalies and extend geochem surveys. Third phase, also success contingent on the second phase, will further investigate anomalies and select most appropriate for drill targets

Gold Giant Claims - located some 5 miles west of the town of Needles in southwestern California. Properties evidence gold mineralization in veins and vein continuity on strike. A three-state program is recommended to locate additional lode claims; compilation of existing data and followup field mapping sampling and fill in geochemical or geophysical surveys; and; drill for targets identified in the previous stage

Lucky Boy - 100% interest in 7 claims being three crown grants and four located claims all under option from Cominco Ltd. about 1 Km south of the former operations of the HB Mine in southeastern British Columbia, near Salmo
