Re: Midway Mine - Moyie Lake

The Midway mine is an old gold property which was explored during the early 1930s. It is a quartz vein dipping 30 to 50 degrees east cutting Aldridge quartzite. The vein is developed by an upper adit about 1,250 feet long and a lower adit about 1,050 feet long. For the first 300 feet the vein is 5 to 8 feet wide but beyond a fault the vein ranges up to 3 feet in width. Sulphide mineralization is pyrite, arsenopyrite, chalcopyrite and minor galena and sphalerite. Gold values are associated with heavy sulphide mineralization.

The average grade of the 1,288 tons of ore shipped was:- gold, 0.23 oz./ton; silver, 2.14 oz./ton.

The last work of which there is record was done in 1965 and 1966 by Calix Mines Ltd. No ore was shipped.

There are no assay plans or detailed information available here to enable a tonnage: grade appraisal of the property to be made.

If the mine does indeed contain 150,000 tons grading \$45.00 per ton then possibly the company's best source of money might be a loan from the Industrial Development Branch to finance a mill.
