Dear Sir: Re: Rob Claims - Alberni, M.D.

In accordance with Section 52 (2) (b) of the Mineral Act we submit the following information on the Rob 1-24 mineral claims (Record Nos. 13470-13493 incl.) which were allowed to lapse on December 2, 1974.

1. Geological & Geochemical Surveys together with bulldozer and hand trenching were completed on the property in 1969. (See Assessment Report by J.E. Christoffersen and D.K. Mustard filed December 1, 1969.)
2. A Summary Report of the history and geology of the property by J.M. Dawson dated May 4, 1971, (a copy of which is enclosed) prepared for Dictator Mines Ltd. who optioned the property from Amax in 1971.
3. Magnetometer Survey of the Property by A.W. Mullan and P.G. Hallof for Dictator Mines Ltd. in June 1971 and filed as assessment work June 24, 1971.
4. Geochemical Survey of the Property in Aug-Sept. 1971 and June 14, 1972 by Tri-Con Exploration Surveys Ltd. for Dictator (a copy of which is enclosed).
5. 78,100 feet of line cutting and 700 cu.ft. of trenching by Dictator Mines Ltd. and filed as assessment work on Nov. 22, 1971.
6. Geological, Geochemical and Geophysical Report on the Property by Tri-Con Exploration Surveys Ltd. October 1 - December 8, 1972 for Dictator Mines Ltd. and filed as assessment work December 1, 1972.
7. Report of 1972 Drill Program by Tri-Con Exploration Surveys by A. Homenuke and W.G. Stevenson for Dictator Mines Ltd. (a copy of which is enclosed).

Approximately \$69,000.00 was expended on the property by AMAX and Dictator Mines Ltd.

The three enclosed reports and those listed as being contained in your assessment files constitute the information available on the property. It is our intent to comply fully with the above mentioned Section of the Mineral Act. Please inform us if there is any additional information required.
