

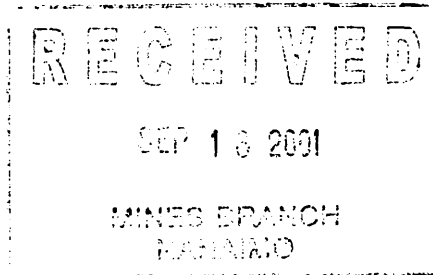

Regarding: Statement of work on Sabine Mineral Claims located at Anderson Bay, Texada Isl.

Dear Alf

My company has been contracted by Carl Hagman and Rick Jones who are co-owners of the Sabine Mineral Claims to conduct a terrain/geological survey of the Sabine property.

I write this letter to bring you up to date on the progress of work completed on the claims and to justify the "statement of work".

The main goal of these claims is to develop and explore the huge deposit of Pink Marble.

The work on the claims will be on going for the years to come, depending on weather and economic conditions.

As the common anniversary date for the claims is September 15th 2001 I am submitting all work completed to date.

The terrain assessment is incomplete as of now but we have scheduled work for late 2001 and 2002.

This work I have claimed on my "statement of work" consisted of 3 field days traversing the mineral claim location line and post positions, elevations, built roads, old roads, streams, rock outcrops, swamps, marble showings and past mining activity.

Also 2 office days entering survey data and mapping was completed.

We are using a computerized terrain mapping program to terrain model the properties, this will allow us to produce a detailed plan for the development of the marble.

As the plan develops we will be looking for different ways of utilizing the resource and the economic benefit or loss of our whole operation.

I have included my invoice that was paid by Gyr Falcon Enterprises, a company owned by Rick Jones and Carl Hagman.

The rates and expenses have been agreed to by myself and them.

Also included in this package is a 1:6000 copy of the working map produced from the field days. I have concentrated work on claims 15 to 25 for now, the rest of the claims will be surveyed at a later date.

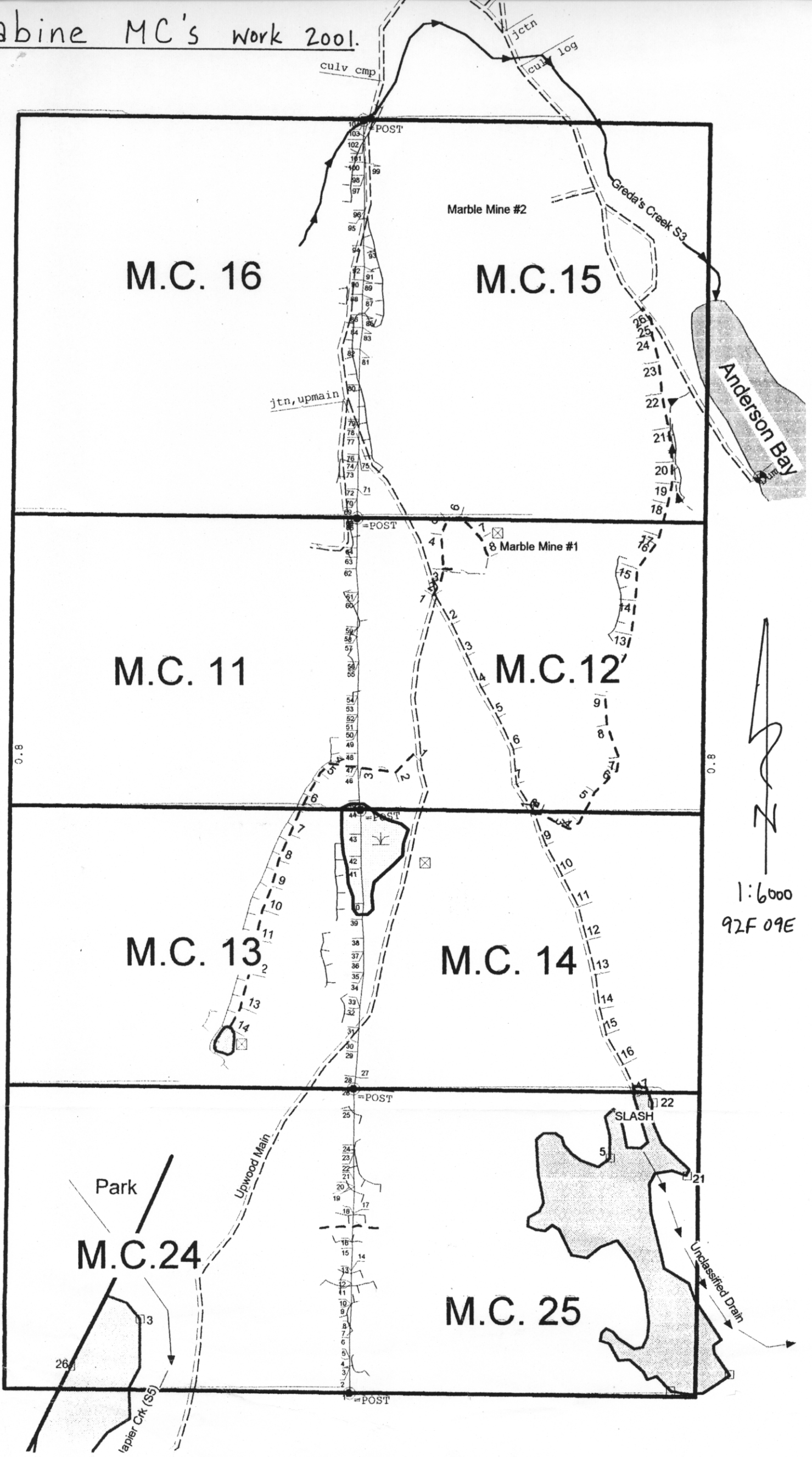
