GEOLOGICAL SUMMARY:

A brief property summary indicates the claims "may" be underlain by Paleozoic Sicker Group volcanics. Rock types include dark grey-green andesitic pyroclastics, dark grey dacite containing quartz "blebs", and light green felsite with quartz stringers. Mapping was confined to stream systems which are described as deeply incised with steep cliffs on either side. Observed float within the valley bottoms includes "banded pyritiferous chert, siliceous massive pyrite, tuff and lapilli which are rock types associated with stratiform massive sulphides". The source of the float is unknown but previous workers have supposed that it originates from the valley walls. No in place mineralization was recorded.

The Mary McQuilton or Abco showing, located west-northwest of the claim group (now in Strathcona Park) consisted of two auriferous shear zones. From 1934 to 1942 various companies explored and worked the showings, known as the Abco Mine. Total production in 1935, 1937, and 1938 is recorded as 72.6 tonnes yielding 7216 g Au, 3204 g Ag, and 265 kg Cu. In 1942, an ore shipment of 807 kg returned 50.7 g/t Au, 24.0 g/t Ag, 0.3% Pb, 0.4% Zn. The property (Abco claim) was allowed to lapse in 1942, but restaked in 1944. No work was done on the property until 1959. From 1959 to 1962 Berton Gold Mines Limited constructed docking facilities on Herbert Inlet, built a road to the bottom of the 1930's ore tramline, drove a new 279 m long adit at the 300 metre elevation, and drilled 290 metres at the face of the new adit. Since 1962 no further work has been carried out on the showings which are now located within Strathcona Provincial Park. REFERENCES:

GEOLOGICAL SUMMARY:

The property is underlain by Karmutsen Formation or Paleozoic Sicker Group basaltic and andesitic volcanics. A section of rusty, sericitized volcanic with abundant quartz veining containing up to 5% pyrite and minor chalcopyrite. Samples from quartz veins indicate up to 0.6 oz/t Au and 0.59 oz/t Aq.
