PRELIMINARY REPORT ON THE PROPERTY OF THE MONEY SPINNER GOLD MINES, LTD. BY A. M. RICHMOND RESIDENT MINING ENGINEER

The property of the Money Spinner Gold Mines, Ltd., N.P.L., comprises the following claims: Money Spinner, Wonderful, Prince, Golden Queen, Tellurium, Free Gold, Baby, Neptune, and Star claims, the latter covering a water-power site at the outlet of Fire Lake.

The claims are situated immediately north of Fire lake on the south slope of what is known as Fire mountain. Fire mountain is reached by a 16 miles trail from Tipella, a landing place at the north end of Harrison lake in the New Westminster Mining Division. Tipella is 42 miles by boat from Harrison lake and Harrison lake is approximately 90 miles bo road from the City of Vancouver.

The principal workings of the property are located on the Money Spinner claim at an elevation of 4900 feet above sea-level. The accompanying sketch-map shows the location of the claims owned by the Company, while the sketch drawing by Mr. James Rutherford of Victoria, indicates the workings on the main vein or Money Spinner vein.

An adit tunnel at 4,900 feet elevation is stated to have been driven 420 feet but the writer was unable to examine more than the first 250 feet of this on account of a cave at that distance in from the portal. At about 83 feet in from the portal of this No. 1 level a winze was put down on the vein for a distance of 84 feet and from the bottom of this winze two short drifts aggregating 35 feet in length were extended along the strike of the vein. At 138 feet in from the portal a raise was up 80 feet following the vein almost to the surface. Two small stopes have been excavated near the bottom of this raise.

The level as examined shows a well-defined fissure vein between altered greenstone walls. The vein is well banded and mineralized with small amounts of pyrite and occasionally small amounts of free gold can be found along the banded fracturing in the vein filling. The vein averages approximately 4 feet in width, striking almost north and south with a dip of 50° to 40° to the west.

In the bottom of the above mentioned winze there is evidence of a concentration of sulphides and it is from this place that it is reported by former owners that excellent values in gold were recovered.

When the property was visited a crew of three men were engaged, under the supervision of Mr. Fred Bradley, in collaring the No. 2 adit level tunnel at an elevation of approximately 125 feet below the No. 1 level. This new tunnel was in 16 feet in slide rock and over-burden.

Comfortable tent camps have been erected and much of the old timber in the milling plant formerly operated at this property was being salvaged.

The vein is quite strong and the presence of good gold values at places in the vein is sufficiently encouraging to warrant further work in thoroughly sampling the vein as exposed and cleaning out the workings beyond the wave on the No. 1 level.

A fairly short cross-cut and drift on the new No. 2 level would definitely establish whether or not minable values are located below the winze level from the No. 1 level.
