Re: CD claims, Cutlass Exploration Ltd. - 21 Mile Creek (92J/3E)

The CD 1 to 36 claims owned by Cutlass Exploration Ltd. lie at elevations above 4,000 feet in the basin at the head of 21 Mile Creek. The group adjoins the north side of the Dog and Lori claims which are part of the approximately 150 claim holdings of Northair Mines Ltd. The group is about 10,000 feet northeast of the principal mineral showing on the Northair property.

The principal known mineral showings of Northair Mines Ltd. are at about 3,700 feet elevation on the Warman 1, 10 and 11 claims. The mineral showings lie in a northwesterly trending zone that has a partly explored length of about 4,000 feet. One showing is a quartz vein averaging about 6 feet wide, an explored length of 550, an established depth of 250 feet and an indicated grade of about \$80 per ton. To date about 120,000 tons has been indicated. As a consequence of this high grade gold-silver discovery there have been a considerable number of claims located in the vicinity. There is a considerable amount of interest and excitement engendered because the Northair discovery is a completely new find that was first indicated by a geochemical anomaly in an area of extensive drift cover.

The Geological Division is not aware that there are any mineral showings on the CD claims.

I certainly would not be prepared to accept the statement of an unsigned letter that "the chances of finding any worth-while deposits of mineable ore are quite remote!

Because of the exploration success of Northair Mines Ltd. I would expect there to be a considerable amount of exploratory work done in the general vicinity. In fact the area extending from the Bridge River southward towards Squamish will constitute a study area for Dr. Pearson for the ensuing few years.

The company announced their intention of carrying out a programme recommended by their consultants. It is quoted from the George Cross Newsletter No. 162 of August 20, 1973 as follows:

"For its 36 optioned claims in Brandywine area, J. W. Hogan, P. Eng., 25 Jun 73, recommended a two phase program comprising \$21,000 for a geochemical survey and \$45,000 for diamond drilling. This property is 8 miles north of Brandywine at the headwaters of Twentyone Mile Creek with access by helicopter or by foot a distance of 2-3 miles from Northair Mines Ltd. access road. Topography is rugged, with elevations of from 4800 to 6500 ft.

The consultant says the Cutlass claims have the same indicated geological environment as the nearby Northair silver-gold property and thus present a good target for exploration. The company proposes to proceed with his recommended 2-phase program which calls for road work, soil sampling and detailed geochemical sampling at estimated \$21,000 in Phase 1 and, depending on results, \$45,000 for diamond drilling and road allowance in Phase 2."

I would assume that the initial geochemical survey would be carried out with helicopter providing access.

Information has come to me regarding what I consider to be an outrageous situation in the making, concerning one of our more beautiful, easily accessible local alpine areas.

The area concerned is the headwaters of Twenty-One Mile Creek in the Rainbow Mountain area, west of Alta Lake; I am sure you must be familiar with the area.

A group of mining claims have been located for some time covering the alpine meadows from Sproat Mtn. to Raibbow Mtn. An examination by me of these claims and a knowledge of the country extending over many years leaves me with the impression that the chances of finding any worth-while deposits of mineable ore are quite remote. However, the damage that could be done to the region through exploration work and road-building would be incalculable.

This latter has, none-the-less been proposed by a local junior exploration company, Cutlass Exploration Ltd. The locator and vendor of the claims in question is John Millette of 885 Dunsmuir Street, Vancouver. Another company, Northair Mines is presently conducting an underground exploration programme north of the Callaghan Lake road. This, I feel, represents no urgent problem, since they are below tree-line in a area committed to logging anyway.

I must apologise for remaining anonymous at this point, but I speak from within the industry and am therefore in a somewhat delicate position.
