## 1. EXECUTIVE SUMMARY

Tre Guis Minerals Ltd. ("Tre Guis") and associates are owners of mineral claims situated on southwestern V Island, BC. The Golden 1-8 claims are located north of the San Juan River approximately 75 km northwest Block A and Block B "Gold" claims are located south of the San Juan River just east of the community of Pc

The properties are accessible by an extensive network of logging roads. A year round exploration season, r labour, power, supply centers and access to deep sea shipping ports all combine to offer favourable logistic

The Golden 1-8 claims are underlain by predominantly metamorphosed intrusions, volcanics and sediments Coast Complex ("WC3"). Mafic intrusions (Diorites) hosted in the WC3 in the vicinity of the Golden claims a as supported by the presence of appreciable magnetite and local occurrences of Cu and Au. The Vertical Gr data suggests significant portions of the Golden claims may be underlain by the favourable diorites and ass ultramafic intrusions. There are anomalous Cu, Ni, Au and Hg RGS anomalies in this area. Historical and re sampling has returned elevated Cu, Ni, Co, Pt and Pd values. Magmatic Cu-Ni-Co-PGE occurrences are kno elsewhere in the Insular Belt where dioritic ultramafic intrusions are hosted in the WC3.

South of the San Juen River, auriferous quartz veins are hosted in meta-sediments of the Leech River Comp favourable geologic setting for hosting tensional fault related quartz veins associated with felsic dyke and s present on the Block A and Block B claims. Gold and arsenopyrite are present in the quartz veins with high values of up to 104.5 g/t Au being reported in historical Assessment work. Historical rock chip sampling fro established that numerous samples contain elevated Au and As from the area covered by the claims. RGS q are present containing strongly anomalous values of up to 800 ppb. Historical placer gold production has ta "down drainage" from the claims.

Additional exploration programs are warranted for the Tre Guis claims. Exploration programs combining str sampling, prospecting and rock chip sampling are recommended.
