

**BURN PROJECT Mo
NTS 93N/11**

Jim Mustard phoned on March 22/07 suggesting I set up a project to look at Molybdenum prospects in my files. BURN Group was initially suggested since Jim had been on that property briefly in 1975.

The following are notes on files found under NTS designations :-

Each file was re-numbered in the following sequence.

- #1 HOGAN MINES LTD. 93N/11W Report by Seraphim August 10, 1971
Kwanika Creek prospect - low grade Cu, Mo. Estimate 10 million tons @ .6 - .7% copper desirable. Results generally below 0.5% Cu.
- #2 BURN CLAIM GROUP (Adjoining BIX Group)
Geology map Oct. 20, 1971 1"-400'; Shows diamond drill holes 72-1 to 72-12 with depths and dip angles. DDH 72-9 drilled SW -45 degrees to 800 feet appears to be in Mo showing area.
April 24/72 Memo JCS to WRB re footage drilled and payment to Shepherd Ent.
Airphoto overlay with geology; misc. field memos; Assay report for Mo sample taken to Toronto at Syndicate meeting in Conwest office - assay 0.23% MoS₂.
Rough print Cu, Mo soil results.
Soil sample field sheets. (Geochem still looks good !!)
Geology print with weak IP indications.

Letter to Wally Bruce March 1/82 - claims were in good standing to 1987. SNAG and Siberia claims staked by Placer north of BURN - still in Placer's name.
** Includes large map print with boundary of claim groups after filing 1972 diamond drilling.
** Shows positions of diamond drill holes #1 to #11 with depths of holes.
** #9 DDH appears to be in the area of the Mo bearing outcrop.
** Cost of work in JCS writing for 10 years work credit. 2543 feet NQ drilling by Shepherd Ent.
Work done Aug - Sept 1972.
** Sept - Nov 1971 Trenching credit file for work - that would be the work JCS and --- were on when frozen in. Includes time when tractor road was put in.
