Re: Kalum Property, Skeena M.D., B.C.

At the request of the management of Cannon Explorations Ltd., the writer examined the Kalum Property on April 27, 1987, reviewed his November 12, 1986 engineering report and the Howell, Awmack and Stephen, May 15, 1987, "Diamond Drilling and Geochemical Report" on the Kalum Property, Skeena Mining Division, British Columbia. The purpose of the review was to evaluate the 1987 exploration program results and assess the recommendations in the Howell, Aumack and Stephen report.

The expanded Stage I program recommended in the writers April 12, 1987 budget review for the Kalum Property. The 1987 program included the drilling of 1403 feet (428m) in six holes which were drill to test known occurrences, possible extensions and geophysical anomalies. Hole 87K-3 tested the best surface showing and intersected approximately 0.36 oz gold/ton over 1.87 meters. No economic intersections were obtained in holes 87K-1, 87K-2, 87K-4, 87K-5 or 87K-6. The fact that hole 87K-3 is located at the shore of Kalum Lake and in the proximity of a newly paved highway makes it difficult to further develop since no strong extensions were found in holes that tested geophysical anomalies east of the highway.

The initial drill program by Cannon Explorations Ltd. has been successful in locating significant gold values over narrow widths and tests of possible extensions were conducted. Since drill tests of possible extension of the adit zone mineralization were not successful, the writer agrees with the conclusions of Howell, Awmack and Stephen (1987) that, "It is recommended that no further work be undertaken and that the property be allowed to revert to the prospectors."
