Pursuant to your request concerning your property in the Beaverdell area, I am pleased to submit the following information and recommendations. I have an intimate knowledge of the Beaverdell camp and examined your particular property on October 15th, 1968.

# PROPERTY, LOCATION AND ACCESS

The Red Rock property consists of the Rocco Plata claims Nos. 1 to 10 and the Van claims Nos. 1 to 4.

The claims are on Wallace Mountain, 6 miles southeast of Beaverdell, B.C. They adjoin the property of Mastodon-Highland Bell Mines Ltd. on the southeast.

The property is at a general elevation of 4800 feet above sea level.

A good gravel truck road provides access from Beaverdell.

### GENERAL

The Beaverdell camp has produced more than 30,000,000 ounces of silver during the past 67 years. Most of this has been derived

from ground now mined by Mastodon-Highland Bell Mines Ltd., which company has operated a concentrator continuously since the early 1950's, and is currently treating ore at a rate of 125 tons per day.

The productive veins of the area carry 1% to 4% lead and similar quantities of zinc in the form of sulphides.

## GEOLOGY

The rocks of the Beaverdell camp consist of the Wallace formation of tuffs and lavas which are intruded by a quartz diorite batholith. The contact between these rocks is high on the west flank of Wallace Mountain, mainly to the west of the Red Rock claims. It dips gently eastward and has a sinuous southerly trend more or less parallel to the long direction of the claim group.

### PREVIOUS WORK

A series of six adits and several shafts have been driven to explore old showings, chiefly on the Rocco Plata 2 claim.

A few years ago, a minor amount of diamond drilling and tractor trenching was carried out in the area of the old workings.

The results of this work are unknown to the writer.

#### CONCLUSIONS AND RECOMMENDATIONS

Geologically, the Red Rock property is favourably located with respect to the Wallace-quartz diorite contact. What the property requires initially is geological mapping and a geochemical soil survey, and this is to be followed by tractor trenching. This will cost as follows:

The sum of \$35,000 should be available for diamond drilling geochemically anomalous areas and any vein indications disclosed by the trenching. This would be expended as follows:


