## Re: OK Falls - Proposed Virgo Claim Option from B. Niddery - OK Falls

As requested by you, I visited the Virgo claim group on June 30th with the Niddery's. From the map, you will see the claims lie immediately north of the Lynx group. A large ridge running N-S terminates on Virgo claim #10, dropping off to an area of overburden cover and low relief. Outcrop on the ridge showed the coarse grained syenite, typical of the Lynx claims, and on Virgo 10 is a small showing of bornite with malachite stain, similar to the showings on the more southern claims.

Little or no bedrock is evident on the rest of the Virgo claims, 1-25; heavy float does not give an accurate indication of underlying rock type in that a variety of 3-4 rock types can be located within very few feet.

I did not see the claims on the east side of Allendale Lake due to the shortage of time after the northern examination.

I would recommend that Ajax option the northern group of Virgo claims to ensure coverage of the syenite plug; and at the same time give serious consideration to optioning the Agate, Doll, and Tammy claims, as bornite and malachite mineralization is present in this area also.


