Dear Gordon:

Thank you for your letter of July 5th and cheque for \$300. Your attached claim sketch, although not too accurate, does indicate the location of the CRAN and SIKA claim groups which I have checked out with the appropriate people.

The CRAN group does have 52 mining claims and the SIKA group does have 96 claims. The claim numbers, not the record numbers, are shown in the attached sketch (the record numbers will be issued sometime in the future).

With respect to geology, the CRAN group is largely in a valley at elevations below 4500°. Sidenius Creek, a tributary of the Sikanni Chief River, flows northeasterly across the claims from the southwest corner to the northeast corner of the group. The claims are underlain by the Besa River formation of Upper Devonian Age. The carbonate unit of Middle Devonian Age underlies the Besa River at an unknown depth; it is the carbonate unit that is the prospective formation and, in suggesting the program below, we are directing our attention first to finding out the depth of the carbonate unit.

On the SIKA group the carbonate unit outcrops well on the western half of the property. It also outcrops to some extent on the eastern part of the property and hence a considerable part of the property as a whole encompasses the prospective formation. Thus, in contrast to the CRAN group, an entirely different program is recommended. It involves a geological reconnaissance which includes methodical prospecting and soil sampling, where applicable.

Below we suggest phased programs for both groups of claims, which we consider to be well located. In both instances, however, Phase 2 is based entirely on whether the results of Phase 1 are favourable or not. In other words, it is possible that Phase 2 may not be justified.
