Dear Dr. Malouf:

Following your telephone call early Sunday morning, February 20th, I called Mr. Chester Millar, the company president, and arranged to visit the property on Wednesday, February 23rd.

When I reached the property, he refused to allow me to see the core, although this had been agreed upon earlier. However, he did agree to let me see his records in Vancouver and it was understood that we would meet on the following Monday. Unfortunately, he has continuously avoided a meeting with me and accordingly, I am not able to produce a report for you. Mr. Millar seemed very concerned that somehow or other providing me with information for a client might result in "short sales" on the market.

I am attaching two location maps. The geological map shows the mineralized area to be within the intrusive rocks immediately south and east of the volcanics.

The drilling program includes percussion holes at 100 foot centres to 300 feet of depth and diamond drill holes at 400 foot centres to 800 feet of depth. The diamond drill is following the percussion drill. The program is limited so far with D.D. Holes over a horizontal east west distance of 1,200 feet and a north south distance of 800 feet. The work is east west and south of the lake shown in Lot No. 1595.

Based on conversation with Millar and others, I believe the rock to be an altered brecciated micro diomite and the mineralization native copper and chalcopyrite. I also understand the mineralization is not consistent.

I am sorry I have not been able to obtain more complete and useful information. Dr. W. R. Bacon who perhaps you know, is familiar with the situation and I suggast that he is the one person who might be helpful to you.

Thank you for returning my report on Afton Mines and writing a note in explanation of your side of the situation.

I would consider the matter rather amusing, were it not for the implication that my partner, Mr. Crowhurst, a highly respected, mature, stable, mining consultant, was somehow involved in a hoax. The fact is that he was called at 3:30 a.m., February 20th by someone purporting to be you. On Monday morning, after consulting with me, Mr. Crowhurst phoned your office in an attempt to confirm the earlier phone call. He was advised by your secretary that you were in Arizona and your office gave us an Arizona phone number. Mr. Crowhurst tried the Arizona number and received no answer. We mulled the situation over for a day, considered the possibility of a hoax, and then decided that we would go ahead in spite of the unusual circumstances.

I am enclosing our brochure and would be very pleased if you would check on Mr. Crowhurst with Jim Redpath of Dome Mines, Fred Hall of Canada Tungsten, Joe Rankin and Trevor Horsley. Otherwise you may retain some suspicion of our consulting firm. Should you wish to check on me, the same names could pass on my integrity as would George Langford, Murray Watts, Duncan Derry and a host of other professional men whom I know well from my days in Eastern Canada some 25 years ago.

In closing, I might add that you have my sympathy in the present situation and I can only hope that you are able to terminate it satisfactorily in the near future. At least I can be amused by the fact that I went through the exercise of preparing very carefully a report which I am sure I will find handy in the future.

Dear Dr. Malouf:

Mr. J.J. Crowhurst has asked me to prepare a report for you embodying what I know and think about Afton Mines Limited.

Our first association with the property was in 1970 when the firm served as consultants for Great Plains Development Company of Canada Ltd. One of our geologists, Mr. G.D. Delane, logged and split for assay the core from 5 Afton NQ holes drilled in 1970. Two of these holes, 70-3 and 70-4, are pertinent to any appraisal of the Afton property.

During the period April 12 - May 13, 1971, Quintana Minerals Corporation undertook a program of mapping, rock geochemistry and percussion drilling on the Afton property. On the basis of this program, Quintana concluded that there was no room on the property for a porphyry type copper/molybdenum deposit.

In the autumn of 1971, Mr. C.F. Millar, P.Eng., President of Afton Mines Limited, initiated a percussion drilling program in the immediate vicinity of diamond drill hole 70-4. When 18 holes had been completed and some of the cuttings assayed, the writer was asked by Mr. Millar to prepare a progress report on the property. The writer did so and recommended a further program of twenty 300' percussion holes plus six 800' diamond drill holes at a cost of \$102,396.


As of February 21, 1972 Afton has drilled 58 percussion and 4 diamond drill holes in the current program.
