Memo to FileZINC PROJECT 104 '0'/16

Following conversation with John Stollery of Cordilleran and Bruce Mawer of Cominco in Toronto March 10 - 11 Mawer phoned March 17 to enquire into details of J.C.S. Exploration ZINC anomaly near Tootsee Lake.

Maps and a letter were prepared March 17 and delivered by JCS to Mawer at 9 a.m. March 18, Mawer had claim maps showing south west corner of Cordilleran claim group covers zinc anomaly.

During discussion it was proposed 70 units could be staked west of Cordilleran to the Cassiar batholith and north to Tootsee Lake. J.S indicated if we did the staking the down payment would be the cost of staking, that we would like to contract the initial exploration and that we would ask for 10% net profits interest. This was generally agreeable to Mawer with the proviso that the interest would be on those 70 units only.

Mawer was to take proposal to Harden for financing.

The letter and maps prepared March 17 were left with Mawer March 18.

Mawer phoned March 18 to ok staking - J.C.S. arranged with McCrory to carry out work. Maps and data shipped C.P.A. March 19 a.m.


Dear Terry;

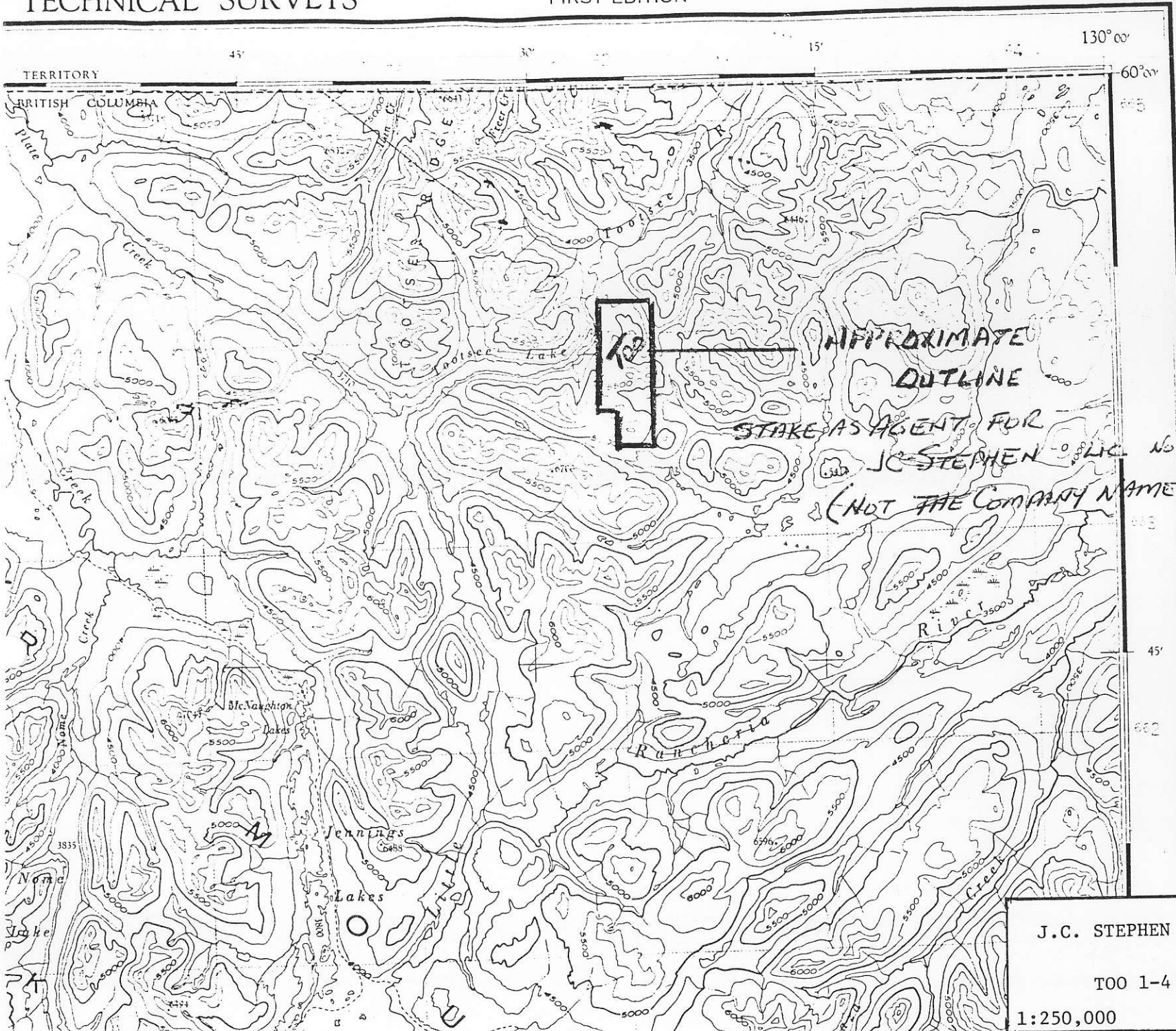

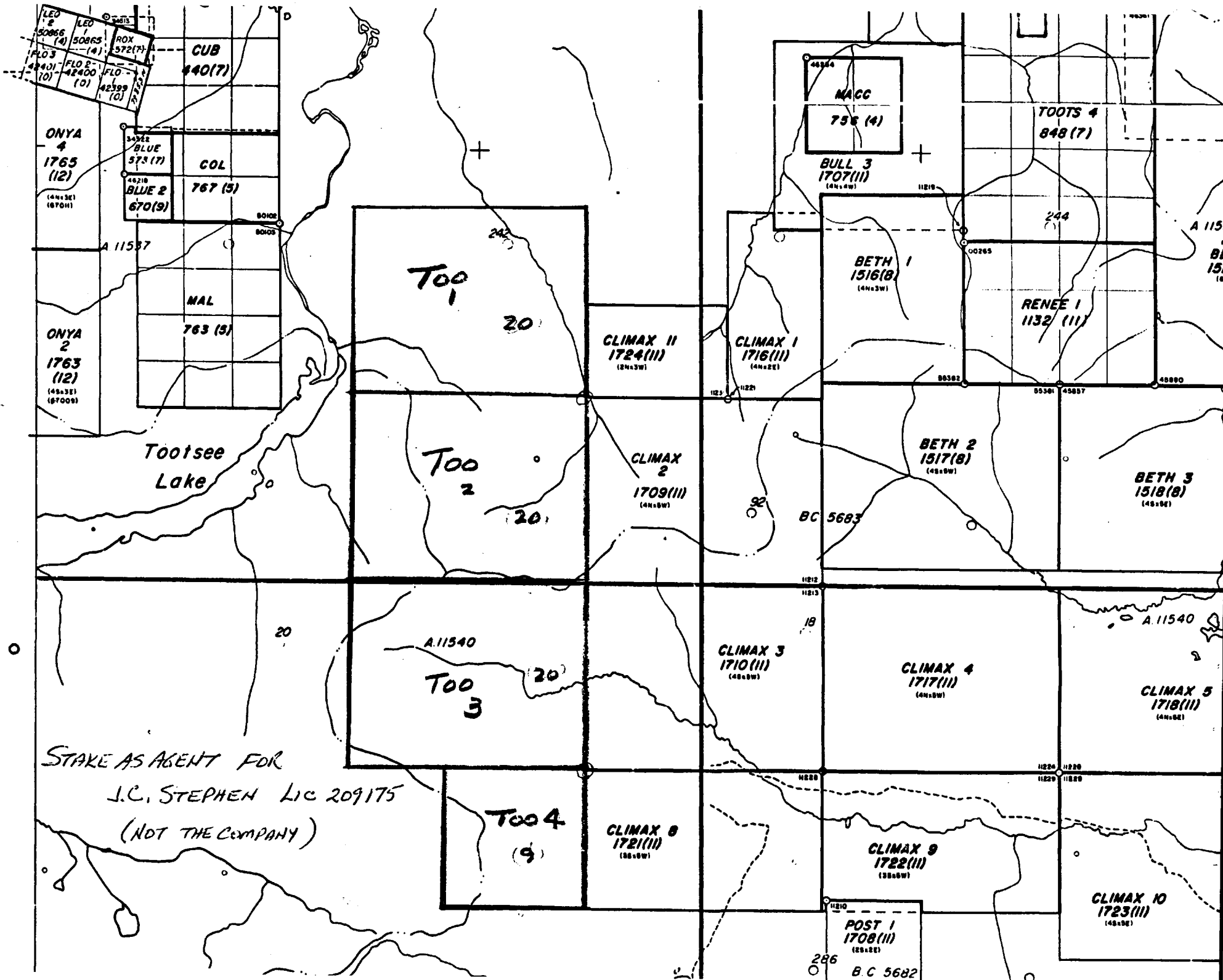
