INTERIM REPORT ON THE KINGFISHER CREEK PROPERTY OF COLBY MINES LTD INCLUDING RECOMMENDATION FOR FUTURE EXPLORATION WORK.

The Kingfisher creek zinc-lead property of Colby Mines Ltd., 39 miles northeast of Vernon, B.C. in the Vernon Mining Division, has been explored intermittently by various operators since the 1950's. Colby Mines acquired and initiated exploration work in the autumn of 1973.

A systematic program of geological mapping, geochemical and magnetometer surveys, stripping, trenching and diamond drilling, conducted from 1973 to the winter of 1974-75, was successful in tracing a significant zone of zinc-lead mineralization in quartzite and marble (RIDGE zone) for about 2000 feet (600 m) along strike. This zone remains open to both the north and south.

Expansion of the RIDGE zone grid in 1974 resulted in the discovery of the CENTRAL zone, parallel to and about 700 feet (200 m) east of the RIDGE zone.

Zinc-lead mineralization occurs in folded marbles in the CENTRAL zone.

Grids were also established on the previously known MILE 8, DAKOTA, and MILE 12 zones in 1974, and mapping, soil sampling, magnetometer surveys and trenching were carried out. These techniques proved to be successful and in each case attractive zinc-lead showings were explored.

In the autumn of 1975, a program of bulk sampling was conducted at two showings in the RIDGE zone. Fifty tons of mineralized material was mined from two open cuts and stockpiled. Most of the rock was from a showing at the extreme south end of the RIDGE zone. Fifteen tons was subsequently shipped to the Cominco smelter at Trail, and were reported to contain 9.9% zinc, 7.1% lead,

0.5 oz/ton silver and 0.03% copper.

A diamond drill hole in the area of this southern showing in 1973 intersected 81 feet (25 metres) of mineralization grading 3.5% zinc and 1.4% lead. The true width of this intersection remains conjectural due to complex folding, but is thought to be at least 33 feet (10 metres).

A program of diamond drilling is definitely warranted to test the extent of the several known areas of attractive mineralization in the RIDGE and CENTRAL zones, and to trace the RIDGE zone to both the north and south.

Also, further surface exploration including grid mapping, soil sampling, magnetometer surveys and trenching are warranted on the MILE 8, DAKOTA, RIDGE, COMINCO and MILE 12 zones. Diamond drilling of targets defined by the above work must be anticipated.

initial exploration should also be commenced on those parts of the property, underlain by favourable lithology, which lie between the above zones.

The above exploration program is anticipated to cost \$103,000, allocated as follows:
