We have 32 hardrock claims in good standing.

Location. Appr. 26 Km East of Quesnel and within the Quesnel trough. The property consists of 16-2 Post Claims, and a block of 16 units. together 32 claims.

The Barkerville Highway, (Highway 26) runs through the middle of the claim group.

There is access to almost all the claims as there is numerous logging roads in the area.'

There is also an abundance of outcroppings.

The Cottonwood River runs through all of the 2 Post Claims, and in the block of 16 units there is a lake, which over half is covered by the claims.

A grab sample was taken in 1981 out of a Rockpit the Dept. of Highways was blasting out for road fill at this time.

The sample assayed 1.42 oz.au. and 9.44 oz.ag.

Some drilling was done in 1986, but no Geophysical Survey or anything else was done to determine the drillsites.

Since then Geophysical Surveys have been done in the area where the 1981 sample was taken, and very good anomalies was recieved.

None of those have been drilled.

In the fall of 1988 we had a Geochemical survey done in the same area by Mr. S. Zastavnikovich, Geochemical Consultant.

His report of the survey with his assay report and recommendations are included with this letter. He can be contacted by phone 946-8785.

We also have a complete report from the geophysical survey done by Mr S. Presunke. Geophysicist, with maps and information over the area surveyed.

The survey was done with a Ronka V.L.F.-E.M.-16 reciever. Serial #20. We the owners of the property, believe there is a very high potential here, and we would like to get some of the high anomalies as well as the Geochemical sites drilled on an optional agreement base.

After this report (As I am sending with) was written, I have located a formation of Rhyolite appx. 50'-60' wide, may be much larger as there is overburden. This formation is located where the goldbearing sample was taken (in the report)
