HAVING DISCUSSED THE TELKWA PASS PROJECT & BUDGETARY DETAILS WITH MESSRS. JEROME & DONALDSON, I CAN NOW ADVISE ON THE GENERAL REQUIREMENTS FOR THE PENDING A.G.S. REPORT BY YOUR STAFF.

I WOULD SUGGEST THAT YOU LIMIT THE ABOVE TO ~~2~~

- A. REVISION (NECESSARY RE-PLOTS) OF YOUR PHASE II REPORT MAP PLUS ADDITIONS OF NEW GEOLOGICAL - GEOCHEMICAL DATA.
- B. PREPARATION OF A SUPPLEMENTARY REPORT; A FULLY REVISED COMPREHENSIVE REPORT IS NOT REQUIRED, OR JUSTIFIED UNTIL WE FIND OUT WHETHER OR NOT WE ARE GOING TO GET ALL THE CLAIMS STAKED.
- C. INCLUDE A CLAIM MAP - PENDING WORD FROM THE MINING RECORDER AT SMITHERS (MR. BELEY); THIS MIGHT ALSO SERVE AS A BASE FOR THE TOTAL GEOCHEM. DATA.
- D. REVISION OF THE TOTAL GEOCHEM. STATISTICS; THIS COULD BE INCORPORATED IN THE SUPPLEMENTARY REPORT.

UNTIL SUCH TIME AS THE EXTENT OF THE CLAIMS GROUP IS ESTABLISHED WE SHOULD DEFER ANY PLANS FOR COMPREHENSIVE INTERPRETATIONS & PROJECTIONS OF THE GEOLOGY. THE SAME RESTRICTION WOULD APPLY TO POSSIBLE SUPPLEMENTARY RECOMMENDATIONS & COST ESTIMATES.

PLEASE ARRANGE THINGS SO THAT WE STAY WITHIN THE GENERAL \$4000⁰⁰ LIMIT SET FOR THE STAGE II PROGRAM - I SUPPOSE A 10% OVERAGE ON THIS WOULD BE ACCEPTED, IF THE TREATMENT WARRANTS IT.
