THE FOLLOWING IN REPLY TO YOURS OF SEPT. 21ST;
THE TOMMY GROUP APPEARS TO BE O.K. UNTIL
NOVEMBER, 1970. (INCL "CHALCOCITE"-"MALACHITE" M.C.S.)

THE NESBIT GROUP (H.N.-V.V.E.N.) SHOWINGS COULD
BE HELD BY PAYING THE 400.00 ASSESSMENT ON
THE H.N. # 1 - # 4 BLOCK - AS AGREED EARLIER
THIS YEAR. FURTHER INVESTIGATION OF THIS AREA
AND GEOLOGICALLY FAVOURABLE GROUND TO THE
SOUTH AND EAST WILL REQUIRE A ZEBALLOS -
SCALE GEOCHEM. ETC PROGRAM, WITH TRUSTWORTHY
CREW SUCH AS MICKELSON AND KNOX.

ZEBALLOS DRILLING IS OUT UNTIL THE WATER
SUPPLY RETURNS - (NOVEMBER?). BY LATE FALL
THE WEATHER MAY BE TOO ROUGH TO STAGE THE
SCHEDULED SURFACE D.D. PROGRAM. THE
ALTERNATIVE LONG GAMBLE HERE - AND WHICH
I FEEL TO BE A MAJOR RISK - IS TO DRILL
UNDERGROUND FROM THE FACE OF OLD C. Z. NO. 2 DR OR
X-CUT TO 500' - 800' PER HOLE TO TEST THE WESTERLY
A DOWN DIP (1500' LOWER) EXTENSION OF THE ZONE.
AN INSPECTION OF NO 2 LEVEL AND GEOLOGICAL
TRAVERSE UP THE ROUGH WEST FORK OF BIBB
CREEK WOULD BE NECESSARY PRELIMINARIES.

2 - MR. MCCONICLE, SEPT. 22/65

THERE WOULD BE NO GREAT DIFFICULTY IN CLEARING HELIPORT SPACE TO THE WEST OF, AND IN FRONT OF NO. 2 PORTAL. I CHECKED THIS LAST TRIP IN.

RE THE FIDLER GROUP, I COULD TAKE ANOTHER LOOK AT THIS EARLY NEXT WEEK, TRY A FEW SOIL SAMPLES, AND LAY OUT SOME CROSS-STRIPPING ON THE EXTENSIONS OF THE MAIN SHOWING. IF THE RESULTS JUSTIFY IT, WE COULD DRILL HERE AT ANY TIME. PAUL ANARIEFF NOTES HE HAS A MACHINE AVAILABLE. ALLIN KNOX COULD LOOK AFTER SOME WORK HERE AFTER HE HAS THE C.G.Q. COMMITMENT OUT OF THE WAY.

AT PRESENT, THE BEST BET FOR A REASONABLE & SOLID PROGRAM IS THE "E.M." GROUP. BUT YOU WILL HAVE TO COME TO TERMS WITH THE BURRS ON THIS.

ALSO NOTE WE HAVE A LITTLE BIT OF TRENCHING TO DO AT HARRISON L. 1 AND I THINK WE WILL HAVE TO DO SUFFICIENT ON THIS TO DETERMINE THE CAUSE OF THE E.M. - GEOCHEM. ANOMALIES ON THE BUG GROUP. THIS ONE IS EASY TO KEEP AN EYE ON.
