Dear John:

Thanks for your letter of October 22.

In regard to your present difficulty of keeping in touch with Roger Caven, I have also asked George Richardson, Barringer's Vancouver office manager, to tell Roger to advise you by phone re his current progress or difficulties whenever he has the opportunity to do so. G. Richardson tells me, from reports he has received from Roger, that the latter has only skipped two one-half day periods since starting on the Toe group, but did not give dates. Must be one elusive Frenchman you have there - or there's something good at Paradise Lake that we don't know about!

I would guess that the initial Toe I.P. anomaly at 26 N, 48 W is the one recently verbally reported by phone; however, I will be looking forward to getting fuller information on this via his pending sections, with your comments regarding the related geological-geochemical details. I am also hoping that the I.P. indicates mineralization in the general zone of our principal geochem anomalies - specifically within no's. 'l' and'2' zones as delineated by Fabian.

In your next progress report would you indicate the current extent of I.P. coverage, as well as the other details; a small scale grid map, on which the consecutive coverage and principal anomalous areas could be shown from period-to-period, might provide the simplest way to repeat this.

Referring to my October 17 letter to you, I think that, in addition to halting the I.P. for preliminary appraisals on the 8W line, we should also provide for running a full check on one of the strongest Geo-X lines-such as line 15+00 E or, if access gets difficult, line 0+00 E at least. We should have this as a check on their work.

In regard to the proposed westerly extensions of the Toe grid, you may find line-cutting here very difficult (burn area?); if this is the case we could get by with lines at 1600' spacing and I.P. on maximum spreads (800' - 1200'?). This could reduce intermediate line-cutting to specific intervals.

White Also, John, let me know as soon as possible if you think you may require any supplementary geological reports for assessment-filing pumposes, in addition to the Barringer I.P. and Bondar-Glegg geochem. reports, which you will have. In connection with the Douglas Lake Cattle Co., rights and restrictions, to what extent would Lots 607 and 636 cut into our Mal-Chal grid? I assume that they would hold the base-metal (Cu, Pb. Zn, etc.) rights on these lots, and only the gold-silver rights could be claimed by the Comapany Are there any other lots in our claims area carrying these restrictions. Interesting to learn that the Kamloops Land Office closes at 3:00 p.m.; this would allow about two effective hours per day after coffee breaks: How's hunting - get any geophysicists yet?
