Dear Bill.

Have been going to write you all summer but just did not get around to it.

We finally got started up Scranton road on July 11, 1961 went right on up to Upper Pontiac & started to look for vein about 60 ft. below lowest tunnel. by Aug 7, th. we had located vein. Shear was quite wide but only about 2 to 3" of quartz. no lead or zinc. We started our adit and began driving. After about 40 ft. the quartz started getting wider and at 80 ft. was 2 1/2 ft wide. Lead & zinc were starting to show when we hit a fault at 86' quite a strong one and a lot of crushed material when advanced to 101' and it looked as though we were going to pick up the quartz again in the floor when we had to quit. The fault strikes N 10° W. and dips 55° W. could be some ore on the other side. I am putting in a sketch for you.

How are things going for you now I see by the paper where Canam are out of funds.

I would like to ask you a question now
pertaining to the placer claims on Siwash
Creek the this Mr. Preston wants staked.

I have been trying to find out where
this is and if it is possible to go in
there this time of year. Could you
