

Enclosing map showing the AWARD and -A.M. claims in relation to the PRICE group, the claim map seems to give precedence to the PRICE claims over the AWARD'S so I assume that precedence has already been established, if not its an important piece of property and should be looked into immiately.

Enclosed Claim records and map showing Award and A.M. claims in relation to the Price group.

The Award claims seems to be a relocation of ZIB and Bills, location line S.W. of Award location and staked in 1958 and 1959 covering almost the same ground.

You will note that AWARD has a fraction between Price <sup>No prob. here</sup> 9 & 10 and 11 & 12 the reason is that in 1960 Claims 11 and 12 and 9-10 were staked in a South West. direction, starting at at the now 13 and 14 initial post. Claim tag # 366025 and 366026. March 23/60.

AWARD 70 Tag # 403533 staked May 15/60 and covered the ground shown on map as Award 70.

In 1961 Claim # 11 and 12 were staked in North East direction Tag # 411172 and 411171

April 6/61 AWARD 70 was in good standing at that time, it came open in May of 1961. but was restaked in Sept 25/61 and has been held in good standing since.

Staking Har Price 11 and 12 in a North East direction created another fraction which is now known as. RuBy 15 Fraction and left some of the ground open for AWARD 69 which was staked Sept 25/61 and in good standing.

AWARD 71 and 72 Tag 403534 and 403535

May 15/60 and Tag B42357 and B43358. Sept 25/61

Both years. The ground was already covered by Price 11 and 12. and they were dropped in 1962.

Price 13 and 14 Tag # 411173 and 411174 April 6/61 were cut off by A.M. 29 and AM 30 Tag # 275010 and 275012 dated March 27/59. and both in good standing ever since

Price # 28 staked as TAP tag # 316509. staked March 2/58 and VDD tag # 274414 March 15/59. would take precedence over AM 31 Tag # 275012 March 27/59. and a corner taken off. as indicated on map.

Recorded numbers dates and ownership enclosed on separate sheets.

You will notice some alteration on the west side of the map, the initial post. were stationed on the map as they were on the grid Initial of Price 9 and 10. 36 N. 56 + 50 W.

" Price 11 and 12 43 N. - 41. W. -

Price 13 and 14 52 N. - 24. W. -

Although we don't have perfect control on the grid lines the relationship between the two group of claims will not be affected to any extent as they are both taken from the same grid lines.

The proposed road is penciled in blue. and is flagged. all in fairly high ground. and easy going 9 culverts will be required, the larger creek following 50 W base line can be crossed at a number of places and the road can be carried on North or South

to the East there is a road at present following 20 E base line to 64 N. and turning Eastward to Deer lake. from this road any anomalous zone can be reached.

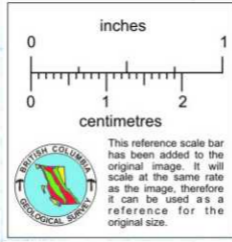
