D. ### A Sad Fatility

A strange and sad fatility was that which occurred above Rock Creek during the first part of last week, when W. H. Miller, a draughtsman, attached to the C. P. R. survey party under the superintendence of Mr. J. A. Odell, come to his death as the result of exposure and a serious mental state.

It would seem that one of the men working on the survey, came to Rock Creek on Sunday the 22nd leaving the camp at the mouth of James creek in the morning. In the afternoon he returned to camp, and with him Mr. Miller went part of the way. After going some distance the two separated, Mr. Miller to return to Rock Creek, and the other party to proceed to the camp. Instead of returning to Rock Creek, the deceased wandered around for some time, and there about eleven o'clock came near the camp at James creek and shouted while standing about 50 yards away on the trail. One of the men hearing the shouts came out of his tent and as soon as he did so the deceased ran-away. This action on the part of the deceased caused the man who came out of his tent to believe it was one of the other boys belonging to the survey party playing pranks, a possible inference as some of the men were sleeping in a cabin a little back from the river while others occupied tents near the streams. Nothing more was heard of the deceased, but in the morning many fresh tracks were noticed near the cabin as if some one had approached it and then retired several times. An overshoe was also found and recognized as belonging to deceased. This led to a messenger being despatched to Rock Creek to make enquiries and as soon ascit was learned that Mr. Miller had not returned there, the messenger made all haste to the camp and a search, was at once instituted, with the result that the deceased was found near the trail some distance beyond the camp, in ans unconscious condition. though everything that could be done under the circumstances, was done to restore him, he did not rally, and life gradually ebbed away during the afternoon of the same day.

The body having been moved to Greenwood a post mortem examination was made, with the result that it was disclosed that the deceased died from apoplexy.



## BUCKHORN BONDED.

E. A. BIELENBERG MAKES A BIG

Deal—A South Deadwood Camp Property Secured by Eastern Capitalists—Big Figure Paid.—Company to Be Organized.

The deal was arranged by O. G. Sabaree representing the syndicate, and W. T. Smith and J. C. Haas representing Mr. Bielenberg. The price paid was \$30,000 cash and 200,000 shares in a company which is being organized with a capital of \$1,500,000 to develop the property.

The Calumet was located in 1894 by R. C. Johnson and R. McCarren. It adjoins the Golden Crown and the Winnipeg, and was under bond for some time to the Golden Crown company. This company threw up the bond last year, not because they did not appreciate the value of the property, but because they wished to confine all their attention to the Golden Crown. The Calumet has been developed by several open cuts and crosscuts, exposing a large vein of rich pyrrhotite. It is understood that the syndicate intend developing the property at once. The deal was negotiated for the owners by W. S. Keith.

### The Oro Denoro.

Montreal capitalists are becoming heavily interested in Summit camp properties. It was a Montreal syndicate who purchased the B. C. mine for \$300.000, and now Montreal people have bought heavily into the King Mining company. The King company own the Oro Denoro in Summit camp. The deal was arranged by Messrs. 

Other properties were brought into prominence because drifts and crosscuts run at different levels demonstrated the quantity and quality of the ore: Under the superintendence of Manager G. H. 
