(Texas Creek)

A contract for 3,000 feet of diamond drilling has been let by Texas Creek Mines Ltd. to test mineralization at its molybdenum prospect near Lillooet.

Texas president R. A. Brossard said drilling has started on the 63 claims at a spot where mineralization is evident but not at the main showings. Meanwhile a road is being pushed to the main showings.

Brossard said the company has spent more than \$150,000 on surface examination, geophysical survey, and building 13 miles of road from the 1,000-foot level on the Fraser River at the mouth of Texas Creek to the 8,000-foot level at the headwaters of Texas Creek and Phair Creek where the molybdenum claims are located.

Brossard said surface samp-ling indicates a large mineral-ized area and that geophysical surveys tend to confirm this.

The current program of exploration includes trenching in addition to road building and drilling. Two bulldozers, a portable percussion drill, road machinery, trucks and jeeps are on the property. A power shovel is being brought in.

Texas is a subsidiary Cumberland Mining Co. which holds a 60 per cent interest.

Giant Metallics

Induced polarization survey is under way at the 81-claim Giant Metallics property of Mines Ltd. in the Adams Plateau 50 miles northeast of Kamloops.

At the same time a magnetometer and soli survey are being conducted in a search for suitable diamond drill targets. Meantime drilling is to start on ore known from old records of this area. the silver-lead-zinc property.

Alfred Allen, consulting geologist, said two bulldozers are in operation and a crew is laying out a gridlines at 100-foot intervals 300 feet apart.

Allen said Cominco drilled on the property 20 to 30 years ago and that the results are not known to Giant Metallics.
