'J' Project - Linecutting  
Progress Report to July 31, 1969

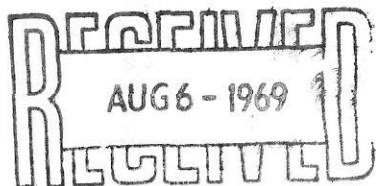
The project of preparing baselines on the 'J' claims near Boss Mountain was begun in Vancouver on June 23rd, with the collection of camp equipment and mobilization of men and equipment. By the end of June lines had begun from the initial posts of claims J-1 and J-2. Four men were employed on the project. Work continued uninterrupted until lines were completed on July 23rd. Two men have spent their time from July 20th searching for neighbouring claim posts and all four men were employed after July 24th completing the tie-in of neighbouring claim lines. A map is currently nearing completion of the location of these base lines and the neighbouring claims and will be forwarded when complete.

On Saturday, July 26th, one-half day was spent by the Alrae crew foreman showing the McGill geologist the method of staking claims in B.C. Four additional claims called the 'R' claims were staked by Mr. Sinha immediately to the west of claims J-150 and J-156. The Alrae crew arrived in Vancouver on July 27th.

The enclosed photostats are of a newspaper article concerning work on the Silver Boss claims which adjoin the 'J' claims which may be of interest to you. This appeared in the Williams Lake Tribune, July 23rd, 1969.

# vs Exeter Mines Ltd. exploring Timothy

A geological team is carrying out exploratory investigations on Timothy Mountain for Exeter Mines Ltd., a non-public liability company.

This was revealed by company president Fred Scholz, who confirms that Exeter Mines has acquired 48 mineral claims (The Silver-Boss group on top of Timothy Mountain) actually Takomkane, adjoining Brynnor Mines Boss Mountain Division of Noranda Mines.

The new mining company was incorporated as a private B.C. Mining company in June of this year, has also acquired 18 claims in the McLeese Lake area of the Cariboo mining division adjoining the property of Gibraltar Mines.

In addition it has 25 claims in The Highland Valley, approximately nine miles south of Spences Bridge in the Kamloops Mining Division.

Under the direction of Thomas T. Tough, Exeter Mines has completed a detailed geological mapping and geo-chemical sampling of the claims in the McLeese Lake area and is now doing the same type of exploration on Timothy with an additional crew of three men.

They were flown in by Leo Lannon Helicopter Ltd. from the Williams Lake airport on July 13 and will remain on the mountain until all mapping and sampling has been completed.

They are working from a base camp to which all equipment was flown in.

In the new future it is planned to convert Exeter Mines into a public mining company, with the intent of offering shares for sale to the public by a Vancouver Brokerage house.

Consulting geologist with Mr. Tough is E.P. Sheppard who has reported to Mr. Scholz that the airborne magnetics show the claims on Timothy lie in an anomaly similar to the adjoining Boss Mountain anomaly.

He said there are strong shearing cuts north-easterly across the claims that carry quartz veins with varying amounts of copper, gold and silver.
