Re: Notice of Work - Catfish

The Ministry of Environment has no objections to this project subject to the following comments:

All inert, non-combustible refuse such as fuel drums, broken rigging and other construction or drilling refuse must be removed from the site on abandonment and, where appropriate, deposited in an authorized landfill.

If, as a result of drilling or excavating activities, pyritic ores or host rocks are encountered, the potential for acid generation should be determined as early as possible during exploration activities. Any runoff or large amounts of ground water that are encountered in acid generating ore bodies may require special handling in order to prevent acid mine drainage production and contamination of the receiving environment.

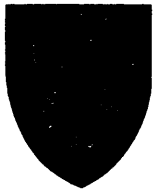
Please ensure that under such circumstances the Waste Management Branch is notified. The results of acid generation characterization tests should be submitted to the Waste Management Branch, Ministry of Environment, Bag 5000, Smithers, B.C. V0J 2N0.

Ministry of Environment bulk fuel storage guidelines have been drawn from the Provincial Fire Code. To summarize, secondary containment is required and must be sized to accommodate 110% capacity of a single tank installation or; 100% of the largest tank plus 10% of the aggregate volume for multiple tank installations. The containment must be constructed and maintained to ensure maximum practical impermeability, and must be placed in a location far removed and sloped away from any open watercourse.

Dear Mr. Flynn:

This letter is your "Notice of Closure" regarding the Catfish Mineral Claims, Atlin Mining Division, of Frame Mining Corporation.

We intend to discontinue work for the 1989 exploration year and return next year.

The work program for 1989 included; mapping and sampling (rock and soil), from three camp locations which have been returned to their original condition; upgrading of an old 3.1 km lease road by infilling washed out sections; trenching at eight locations having a total length of approximately eighty metres, by blasting and hand trenching; line cutting and I.P. geophysical surveying of approximately 10 km.

This week the trenches are scheduled to be backfilled, the road will be protected by water bars on the steeper intervals, and all work will cease for the remainder of the 1989 exploration year.

Access to the lease road via the Klondike Highway will remain open as we intend to resume work in 1990.

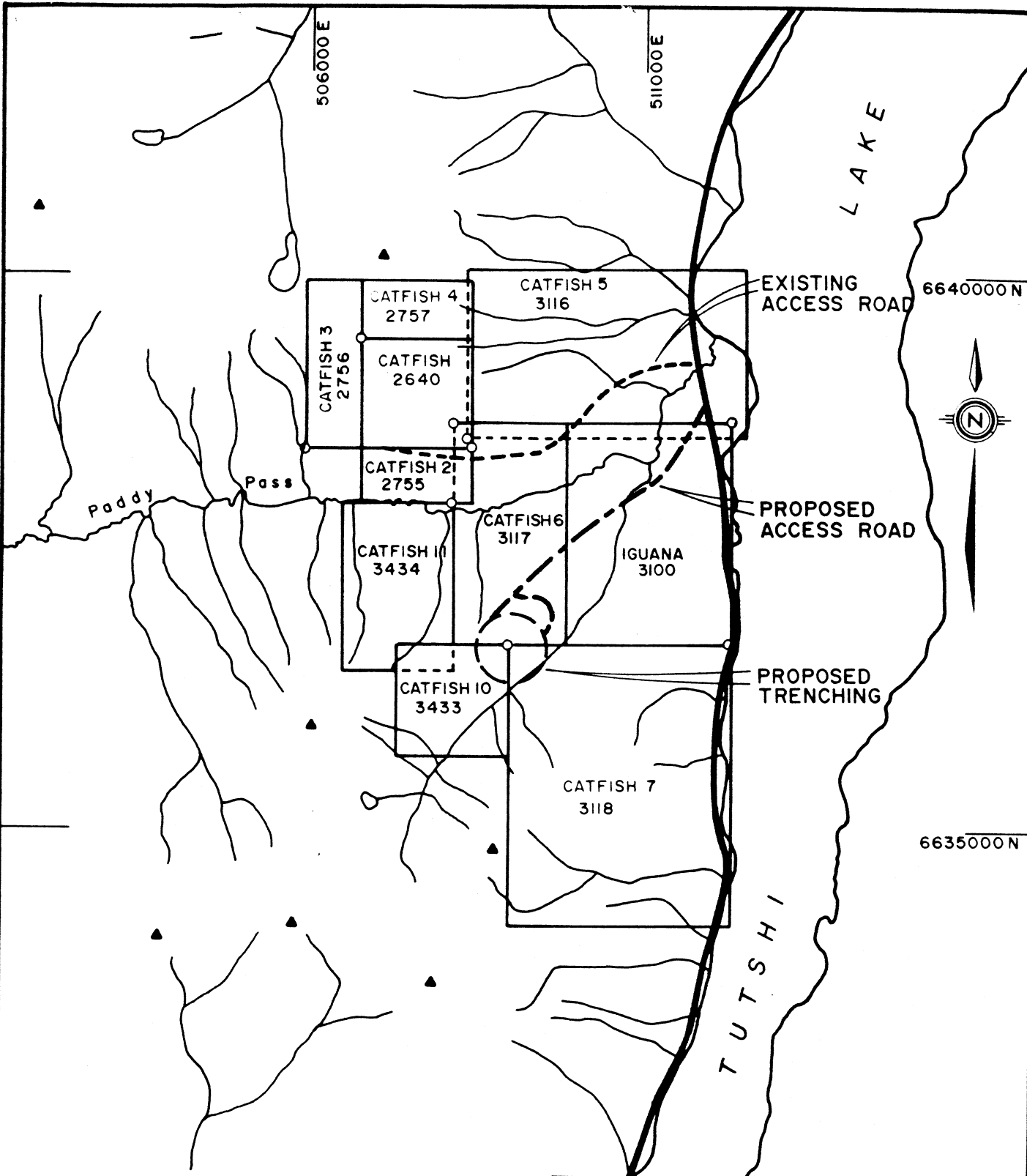

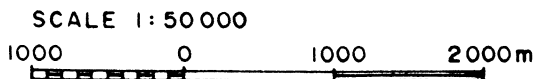

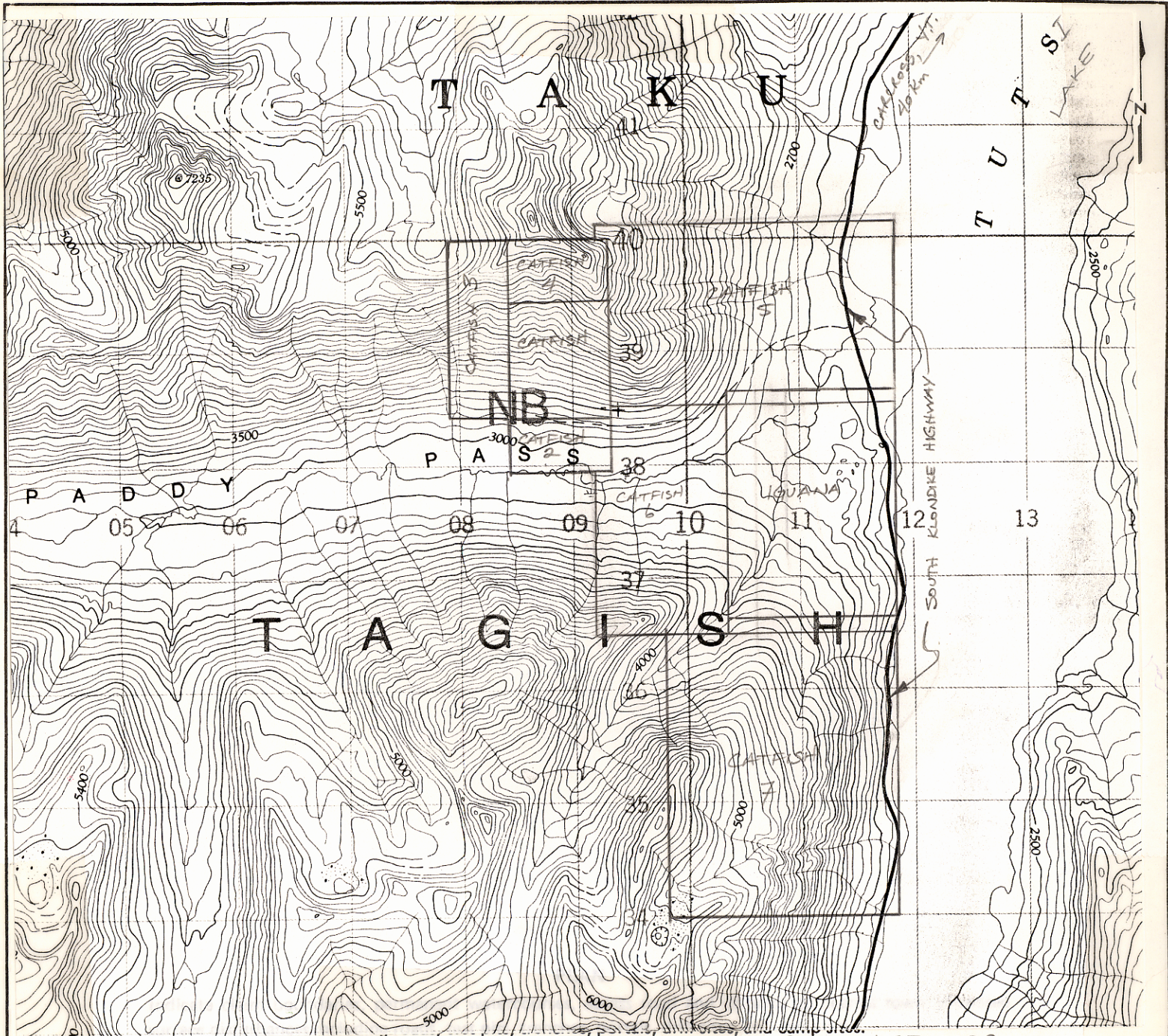

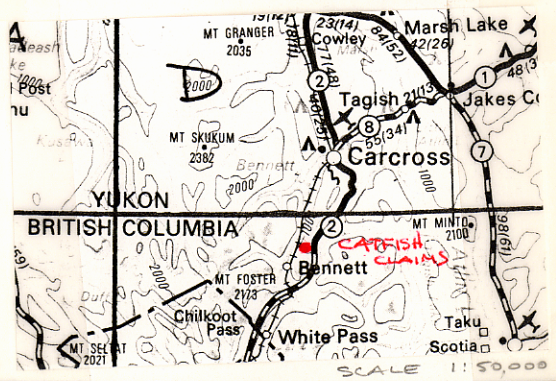
○ LEGAL CORNER POST
