Dear Dr. Griswold:

This will acknowledge with thanks receipt of your interim progress report dated June 15th, 1972.

We note that the start of the diamond drilling program is, apparently, still delayed and wonder how this will affect the arrangement discussed with the Prism Resources vendors in respect of the cash payment originally due at the beginning of June. It seems to us that it would be in order to invoke "Force Majeure" since the delay is caused by the flood situation in southern B.C., and we would like to go on record as favouring this course of action rather than making cash payments on an interim basis, before we have any really good information from the major target area.

Perhaps I could discuss this with you further, at your convenience.

Regarding our Mount Nansen work program, I would like to advise that drilling on this property commenced on June 13th and at this date is progressing satisfactorily. Work involved in getting the access road back into shape was kept to a minimum by having our project geologist supervise the cat work, prior to the start of the field program proper. We estimate that the total cost of the road work, including rental of equipment to thaw the culverts, etc. will be under \$5,000. This compares with the \$15,000 estimate originally given to us by the contractor.

We would be most happy to show you and any of your staff around the property, or to discuss the planned work program for this year, at your convenience.

As you probably are aware, we have negotiated an option on the seven mineral leases owned by Frank Goulter of Carmacks, and the initial payment of \$5,000 has been made. A cash payment of \$15,000 is due under the option agreement on the Wheeler claims, on September 9th, 1972.

We understand that your Legal Department in Los Angeles is preparing an agreement which will be re-submitted for further consideration in the near future. Needless to say, we, in the Vancouver office, would like to see these agreements completed and executed as early as possible.

This interim progress report is a brief summary of the work that Getty Mining Pacific, Limited has done on the Ashnola property this The first phase, which consisted of rotary and percussion drilling, was completed on May 26, 1972. A total of 1000 feet of shallow (less than 200 feet) percussion drilling in 15 holes and 312 feet of rotary drilling in 2 holes was the end result. Neither of the two drilling procedures were successful, due mainly to severe caving caused by the fractured nature of the rock. Because of extremely slow progress the rotary drilling was terminated on May 25, 1972, and the percussion drilling was stopped the next day due to relatively unsuccessful penetrations.

In order to meet assessment requirements much of this initial work was done in regions peripheral to the main area of interest. surrounding holes were generally low in copper. The best hole (P72-7) was in the central area of the pyrite halo but a rotary hole that was within 700 feet of this had comparatively low copper values. or a difference in sampling techniques of the two drilling procedures could be responsible for this sharp contrast within such a short distance.

A diamond drilling program is scheduled as the next phase of work. This will consist of a minimum of 1000 feet drilled in the main area. of interest. Initially, three 500 foot holes are planned. The start of this program is being delayed for an indefinite period of time due to the fact that both routes into the property have experienced washouts.
