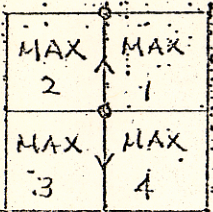
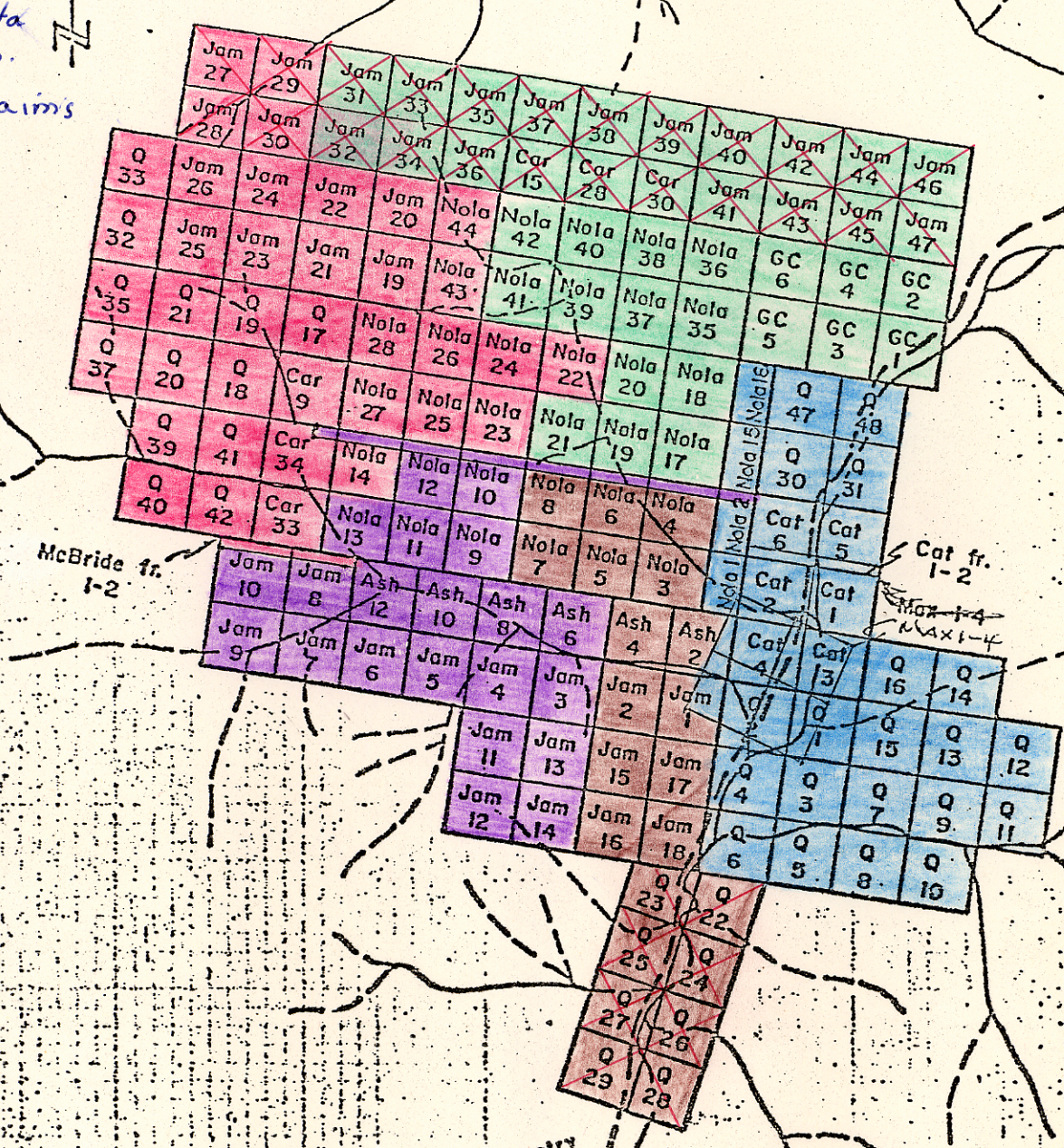


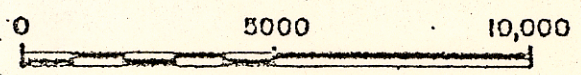

ASHNOLA RIVER PROPERTY.



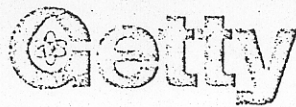

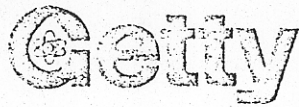


