Trans Mountain Oil Pipe Line Company reports that the total deliveries of petroleum for February, 1968, averaged 254,849 barrels per day compared to 232,222 barrels per day in like period of 1967.

Deliveries through the system for March, 1968, are expected to average 250,000 barrels per day.

✓ New Imperial Mines Ltd. has reported that holes 102 and 108 drilling at Middle Chief have both intersected good ore at sections 10,450 feet north and 10,300 feet north respectively. Previous drilling has intersected middle Chief ore at 10,100 feet thus this ore body is shown to extend a total of 350 feet in strike length with present drilling. Drilling is to continue with hole No. 111 on same section as hole 108 and hole 109 at section 10,600 feet north. Assay results from these holes will be released as early as possible Wednesday morning, March 6, 1968, the company reported.

Inter-City Gas Limited has declared the third semi-annual dividend of 62 $\frac{1}{2}$ ¢ per share on the 6 $\frac{1}{4}$ % Series "A" Cumulative redeemable second preference shares, payable April 30, 1968 to shareholders of record April 12, 1968.

✓ Chieftain Development Co. Ltd. president, S.A. Milner, in reviewing the company's operations states that Chieftain, its associates Blue Crown Petroleum Ltd., and Dome Petroleum Limited have selected two drilling locations on the Larne Creek properties. Equipment is moving in to "Dome Chiefco BluCr Larne 16-32-117-1W6" which will be drilled on a 5,920-acre drilling reservation farmed out by Tenneco Oil & Minerals Ltd. The Dome-Chieftain-Blue Crown group will thereby earn a 50% interest in the acreage. The same companies are also drilling "Dome Chiefco BluCr Larne 4-34-117-2" on one of two adjoining 320 acre leases, three miles west of the above acreage. Information derived from this well will help evaluate parcels to be offered for sale by the Government of Alberta. The wells will be drilled "tight"

The location is being prepared for the first well, "Dome Chiefco Arco BistS 10-30-120-2W6," to be drilled in the northwest corner of the property acquired from Atlantic Richfield Company being 54,400 acre South Bistcho. If sufficient time remains before spring breakup, the second well will be drilled immediately following completion of the first.

Chieftain and Blue Crown have a 50% working interest in a 17,920 acre reservation which borders to the west the South Bistcho. Home Oil Company Limited has conducted extensive seismic investigation and drilled two wells; one of them is a gas discovery, and the other is suspended pending further evaluation. The James Creek property, a 39,680 acre reservation in which Chieftain and Blue Crown share a 50% interest, is virtually surrounded by very promising activity.
