A Mr. M.V. Nixon of Multiple Mining called this office as a follow up to correspondence from Mr. Ferris of Red Deer Motors concerning prospects which this Company holds in Southern B.C. In particular they have a copper prospect just south of the No. 3. Highway and about six miles West of Osoyoos. I met with Mr. Nixon, and a Mr. Watson of Cranbrook who is a Director of the Company also, this afternoon, and discussed briefly these prospects. The work which has been done on the copper prospect consists of preliminary mapping and some geochemical soil sampling and has been under the supervision of Mr. Ron Renshaw.

This Company also holds a property in the Cranbrook area which they regard as having potential as a gold producer. They have agreed to send us all the information they have on this property also and I have suggested that we would take a look at this later when conditions permit.


Thank you for your letter of February 6, and your expressed interest in having a look at our properties.

Dear Sirs:

Mr. Patrick, Minister of Industry in Alberta, has given me the name of your Company as one interested in the development of ore bodies.

I am involved in a Company which has some interesting holdings in the Silver, Lead, Zinc minerals in the Nelson area, and Copper holdings in the Osoyoos area, both in British Columbia.

While we have not done a lot of work on our Copper claims, the examination we have had indicates a reason for more extensive exploration. Assays taken have shown Copper, a little Silver, and a trace of Molybdenum to the value of approximately \$4.20 a ton. We have staked ninety-six claims in one block in this area, and approximately eighty-eight are valid claims, the balance having prior rights established. They are located approximately eight miles west of Osoyoos and probably about thirty-five miles south of the Brenda property.

Accessibility is good, the terrain can be pretty well traversed in a Jeep, and open pit mining should be a relatively simple matter.

We believe from the anomalies outlined that a thorough drilling program could be a productive program.

The Silver, Lead, Zinc holdings involved two to three hundred acres north of Nelson, B. C., in the Ainsworth, Kaslo, Gerrard area. We are endeavouring to block out or outline the extent of the ore bodies at one location at the present time and have a crev under a qualified Geologist busy drilling there now. The ore samples here are assaying from thirty dollars a ton to two hundred and twenty-nine dollars a ton, and we believe we have better than 200,000 tons determined now at this level.

Since we have only looked at about an acre of this holding and it consists of two hundred, we believe that it is conceivable that we might be on to a very good mine here.

We are a private Company with limited funds. By the end of January we will have spent around eighty thousand dollars on the exploration work at both Osoyoos and the area north of Nelson.

Right now, we are trying to decide whether it would be better to raise more moeny and bring the Silver, Lead, Zinc into production, then go back and finish our exploratory work on the Copper claims, or to invite participation from a major firm such as yours.

I would be delighted to hear from you with your reactions to such an idea and would be happy to meet with you after the first of the new year to discuss our program in detail and any proposition you might care to put forward.
