Spud Huestis phoned to day from Vancouver regarding the terms of purchase of a 23 claim group near Hobo Creek, Atland District, belonging to this company. Huestis states that they will option their 23 claims to us for a total of nine or ten thousand dollars cash, plus a 25% interest in a 3 million share company. I advised him that I would let him know regarding our decision in the near future. It would not appear that they are interested in developing the property on their own behalf. Without further information on the importance of the ground I would not be prepared to offer him the above terms, and suggest that we offer him an alternative proposal to purchase our ground at reasonable terms. It might be possible to include in our next years schedule of work for the Yukon, a dip needle survey of our group plus a limited amount of packsack drilling to determine if any copper zones are present on our property.

Huestis stated that the Bethlehem Copper ground in the Highland Valley was responding favourably to diamond drilling and they now had outlined in the jersey zone 56 million tons of .7% to .8% grade in copper to a depth of one thousand feet. The mineralized zone was open at both ends and mineralization was present in holes drilled beneath one thousand feet. The iona zone now has a potential of 25 million tons of the same grade.
