A Mr. William Blanco called to discuss some float he found in 1954 with the idea that we might hire him with another man or two to prospect the area.

Mr. Blanco is a former miner, age 63, who has apparently been unemployed for some years and is now not in robust health due to silicosis. He worked at trenching for CM & S during part of the 1950's and also prospected for several summers on his own.

His story is that in 1954, he discovered rusty float, on the southwest shore of a 2 mile by  $\frac{1}{2}$  mile lake shown on N.T.S. sheet 94 E at lat. 57° 18', long. 126° 3', some of which assayed 40.6 ounces of silver, 4% copper, 0.06 ounces gold, and 3% lead per ton. He staked 2 claims and did some prospecting and trenching. 800' to the west, on strike according to Blanco, he found a 6' gossan which he trenched but couldn't penetrate.

In 1956 (?) Frobisher sent a man (Davis?) in to look at it. He was going to come back when Blanco finished trenching but never did so.

In 1958 the Wenner Gren people were working on some low grade uranium claims nearby and their geophysicist by the name of Wagner, (probably Eugene P. Wagner whom I know), ran a short 1 or 2 day reconnaissance self-potential survey over the gossan and surrounding area and picked up an 800' x 150' anomaly.

I propose to tell Mr. Blanco that we do not want to hire him to further prospect the area. I intend, however, to indicate to him that I am advising you about the float and that if you consider it worth some attention which results in our acquiring claims on or near the float, he would be entitled to receive 5% of the vendor interest.
