It has been several years since we last communicated with respect to exploration and mine development in British Columbia and although our first co-operative undertaking did not result in the development of a profitable ore body, I do think it was a worthwhile undertaking that had the required potential and warrented the effort expended on it. However, it was indeed unfortunate that some kind of a mine did not evolve from the effort and your very excellent evaluation program.

The Adanac experience in more ways than one, was an education which I have attempted to put to use, especially in regards exploration. Such seemingly incidental items as snow removal, drainage and of course transport and supply costs can cripple what would normally be an economic ore body.

In summary, I have confined my personal exploration activities to a more hospitable economic geographic climatic environment and to a more hospitable mineral.

Of course while working in southern B. C., one has to become geologically more shrewd a result of increased competition. It is also interesting, how one can turn someone else's disposal into something worthwhile by doing one's geologic homework.
