SORATA DEVELOPMENTS INC. (SOA-V)

EZECHOSLOVAKIAN PROJECT PLANNED - Peter E. Kayne, president, reports Sorata

Developments Inc. has eneted into a business venture with Vychodoceske Uhelne Doly (VUD), a State agency of Czechoslovakia, to market, manufacture and install prefabricated panelized building units on a nation wide basis. The venture, in which Sorata will have a 51% interest, will be licensed to use Sorata's technology under a royalty agreement. Sorata will also supply certain equipment and raw materials to the venture while VUD will provide plant facilities, labour, marketing and management staff.

Sorata and VUD plan to produce 200 building units per month after one year, 500 units per month after two years and 1,000 units per month after three years. The average value of a building unit is US\$15,000, plus installation and finishing. The parties expect the project to be operating by spring 1992. The initial budget of US\$500,000 will complete such preliminary steps as marketing studies, Czech Government approval of Sorata's technology and the finalization of VUD's privatization. Sorata will pay a finders fee.

In another development, Sorata has completed the production of stres-skin panels for the Cominco Lead Absorption Tower at Trail, B.C.; construction is on schedule. (SEE GCNL No.132, 10Jul91, P.3 FOR PREVIOUS INFORMATION)

A total of 3,000 feet of reverse circulation drilling is planned for the first series of holes where surface exploration has yielded chip samples with values up to 2.0 oz.gold/ton. additional wells on an option basis. The first test should begin by the end of October with the second test expected to follow within 30 days of rig release of the first test. Each well is proposed to be drilled to about 6,000 feet deep, sufficient to test the thick Eocene Chuckanut sands for prospective reservoirs that may contain significant quantities of gas, based on geologic and seismic information. Drilling each well should require 30 days.

Optima Energy Corp. has a 10.5% working interest in this phase of its Fraser River Delta exploration program in addition to a 1.5% gross overriding royalty on over 70,000 acres under lease in the Delta. The agreement is the continuation of a wildcat hydrocarbon exploration program that began with the AHEL Birch Bay No.1 well drilled in early 1988.
