2. DESCRIPTION OF WORK

The work is to consist of a series of drill holes drilled at locations specified by the Company. A total minimum shall be drilled but total of 3,000 feet may be extended by mutual consent. Holes shall be drilled BQ tools producing _____ 1 7/16" with diameter core. Maximum depth of any hole shall not exceed and minimum depth shall be 400' 1000' The Contractor will not be called upon to drill any hole at a flatter angle than <u>-60</u> degrees. Measurement of all holes shall be taken from the top of the casing pipe. If holes of a greater depth than 1000' are desired, such drilling shall be performed only upon such conditions and at such rates as may be agreed upon before commencement of such drilling.

- (c) The following services will be provided on a site cost plus ten percent (10%) basis:
 - (1) Casing of overburden in excess of 30'
 - (2) Casing operations in bedrock.
 - (3) Stabilization of boreholes for cave, loss of circulation, squeezing ground or artesian pressures.
 - (4) Delays caused by Company.
 - (5) Supplying water to the drill when water supply over <u>2,000 ft</u> lateral and/or <u>100 ft</u> vertical lift from borehole collar under non-freezing conditions and <u>N/A</u> lateral and/or <u>N/A</u> vertical lift under freezing conditions.
 - (6) Surveying of boreholes (acid dip tests) desired by the Company.

 - 3. Operating rate for D-4 dozer for initial move in, preparation of set-up, move out or incidental client work for which the unit is suitable.
