RE: Top Property

On August 11, 1983, Brican Resources Ltd., with your consent, abandoned the TOP 1 - 12 (Rec. Nos. 412 - 413, 932 - 941) and BOTTOM 1 - 8 (Rec. Nos. 1197 - 1204) mineral claims in the Vernon Mining Division, B.C. pursuant to Section 28(1) of the Mineral Act. The above claims were subject to the June 26, 1981 Agreement between yourself and Brican on the TOP property.

On August 12th and 13th, 1983 the area of the TOP property was relocated pursuant to Section 28(3) of the Mineral Act. The TOP 1 - 4 (Rec. Nos. 1563 - 1566) and BOTTOM 1 - 2 (Rec. Nos. 1567 - 1568) mineral claims were located and recorded in the Vernon Mining Division on August 17, 1983; in the name of Brican Resources Ltd.

This letter is written to confirm that the new relocated claims are subject to the June 26, 1981 Agreement as amended by November 10, 1982 Letter of Agreement and all its terms and conditions.

Further to our discussions on Wednesday evening October 5, 1983 we regret that you have misinterpreted the November 10, 1982 amendment to our June 26, 1981 Agreement.

To give affect to what you thought the amendment entailed we enclose our cheque of \$5,500 being the balance of the \$4,500 paid by monthly payments for the \$10,000. payment due November 12, 1982.


