He came to the same conclusion as Clive Ball on the potential of the property. He does not believe our E.M. method would work on these marrow veins, even if the topography was suitable. Exploration, then, by conventional methods like at Keno Hill would be very difficult.

Spoke to Ball reg the possibility of E.M. on the Logjam. He says:

Insufficent iron sulphides to act as a conductor. He said he had already considered that as a possible vein tracer and dismissed it because of the lack of sulphides.

Impossible to conduct a survey normal to the visible vein structure because of the steep slopes. He used a 500 ft climbing rope to sample the veins.

I asked him where the vein went when it hits the crest of the 5350 ft ridge and Clive said there is no outcrop of it over the crest. He thinks possibly it may be talus covered, and for that reason does not outcrop.

Opinion:

If the C. Ball sampling represents the true average width (2.3 ft) there would be very little profit, even if the assumed cost of \$21.00/ton for mining, milling were achieved. It is incorrect to assume that the payment for 60% lead conc. would be at the rate of \$ 0.12 per ton. Present price schedule for lead conc. from CM&S is (no zinc in conc.): deduct 1% or 20 lbs which they do not pay for; payment is made on 92% of balance of contained lead at world market price less 6 cent per pound. You can figure on a price of between 6 cents and 7.5 cents per pound of contained lead in the ore. In this case about \$ 4.00 per ton.

I think that cost wise this location is similar to UKH at Mayo and , there, 30 oz silver is waste, therefore I think Clive Ball's original conclusion is valid.


