
Tom Neelands gave me your message regarding this property and I managed to reach Peter Sevensma on Monday, October 27, 1980.

Peter advised that the property is unavailable inasmuch as Skyline Explorations is working on a rights offering or an underwriting or both. He did not know where Bill Hood was nor did he realize that Bill Hood had contacted Bill James.

I telephoned George Cross in an effort to determine who was reassembling Skyline Explorations and what he knew about the whereabouts of Bill Hood. George had no answers for either question but said he would work on it.

Peter Sevensma said that this was a massive sulphide deposit and that the 10 million tons was not a correct figure. He did not dispute the validity of the grades.

For obvious reasons I have not called Noranda on this matter but I will keep you posted on any new developments.

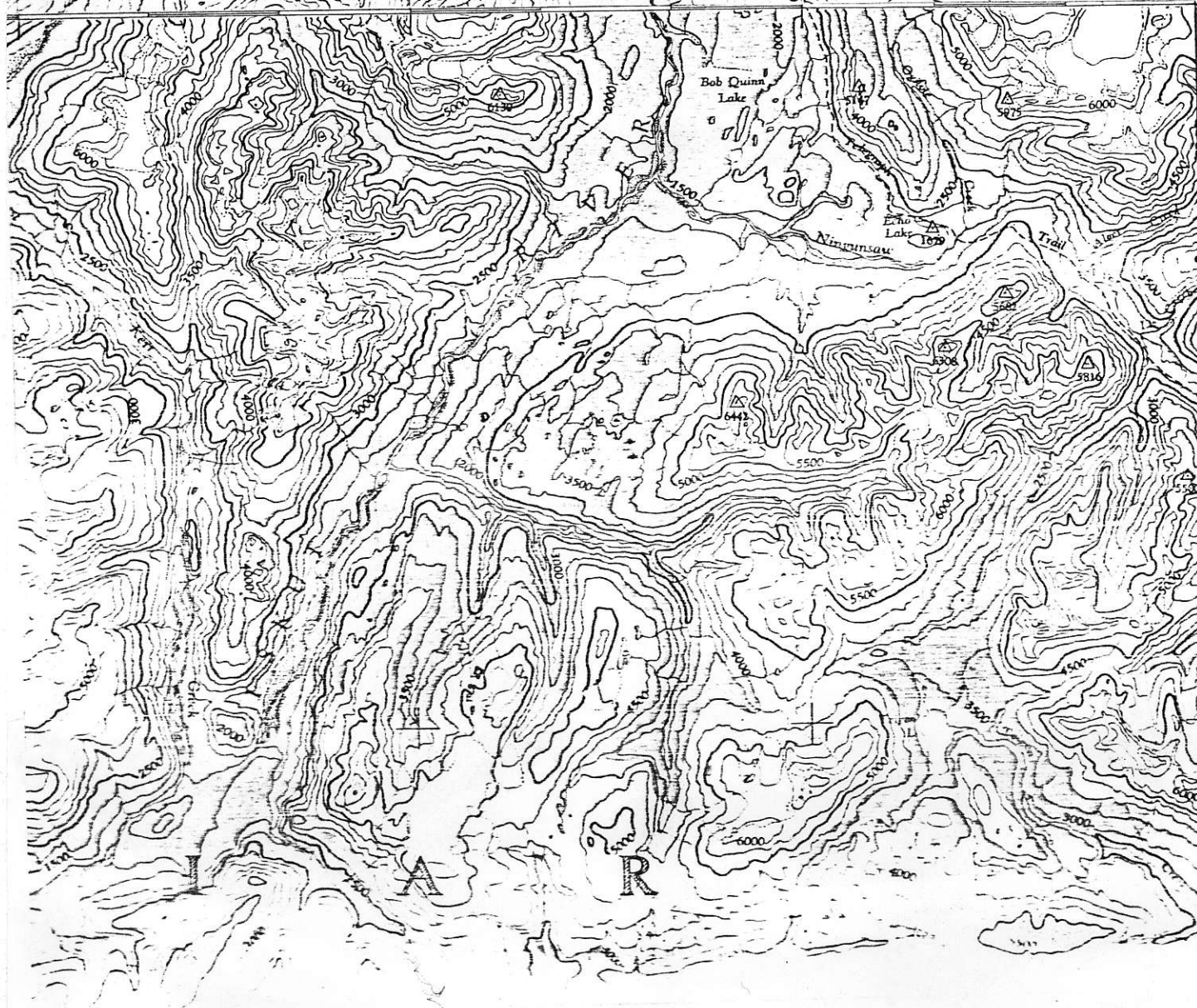
