Robert Beaupre has been working in the area since 1976 and within the last two years discovered in trenches spectacular gold samples which are almost jewelry grade and assayed up to 34 ozs/ton. Some of the samples look as though they would run much higher than that. Diamond drilling in Hole #6 reportedly intersected 1.6 feet of 7.5 ozs/ton gold which was reported in the George Cross Newsletter. Other reported intersections are in the .09 to .02 and less ozs/ton range.

Ted Groves, previously with the B.C. Dept. of Mines is their consultant. He feels that the veins exposed are the leakage veins through an amphibolite which has caused damming of gold bearing solution below the amphibolite and this is the model that they are testing. We have a copy of the Groves Report which is not for general circulation. Robert Beaupre would like a quick answer on whether or not we are interested in optioning the property or joint venturing with another major who are apparently interested in a joint venture proposition between two majors and Beaupre Exploration.

Initial dollars discussed, total commitment over 3 to 4 years of 3 to 4 million dollars of which 1 million dollars would be in option payments staged over time and 3 million dollars would be into the ground. The first payment would be about \$50,000 with a work commitment of \$200,000, for the first 6 months, an option payment of \$70,000 with a work commitment of \$300,000 for the next 6 months subsequently increasing option payments and work commitments.

He does not wish to look at this property as a small high grade operation but rather as a large tonnage low grade operation. He feels that .02 ozs/ton of gold with a large tonnage would be economic. He thinks that the ore would be easily leached because the gold is free milling or it would be very possible to mine and mill by conventional means because the gold is free milling.

The property is reached by driving north from Sooke to Young Lake road, then right hand turn onto Butler Main, then right up hill just before the Diversion dams to the Beaupre camp. Four wheel drive is not necessary.

Beaupre Trench C-36 Sample C83 BP-30. Wall rock, meta sandstone with minor quartz lamination, the trend of the schistose fractures is 080. Sample taken from the south side of the 4cm quartz vein, 4 foot true width.

Sample C83 BP-31. Two to 5cm vertical quartz vein trend 080, chips along 5 meter length.

Sample C83 BP-32 High grade of Au rich pocket in 2.5cm wide quartz vein.


