BOOKER GOLD EXPLORATIONS LIMITED HEARNE HILL AND MORRISON PROPERTIES

Booker Gold has established a copper-gold resource on the Hearne Hill property, and have finalized an agreement with Noranda Mining and Exploration to further explore, complete a feasibility study and jointly develop the Morrison copper-gold porphyry deposit. These deposits are approximately 1.5 to 2.0 km apart in the Babine porphyry copper belt of central British Columbia.

Booker Gold's strategic objectives and conceptual plan are to create the opportunity to develop a combined operation with higher grade Hearne Hill deposit and the larger lower grade Morrison deposit. Earlier evaluations of the Morrison have indicated a submarginal project. However it is anticipated that the higher grade resources from the Hearne Hill breccia-type mineralization will provide the favourable blend of mine production to enhance the economics for a potential mine operation in the early years.

Copper-gold resources have been defined on both the Hearne Hill and Morrison properties. They represent interesting advanced stage projects and constitute strategic assets for Booker Gold who own 100% in the Hearne Hill property, and the opportunity to develop the Morrison deposit. There is exploration potential for additional zones of higher grade mineralization within the Hearne Hill porphyry system, and potential upside for improved copper and gold grades and possibilities to define extensions to the known mineralization for the Morrison.

The property descriptions and proposed exploration programs as presented in the Offering Memorandum and subsequent Prospectus provide full disclosure of the information on the properties. The Hearne Hill property information is based on earlier exploration on the Hearne Hill porphyry deposit and the more recent comprehensive work by Booker Gold. The Morrison data is largely based on the Noranda documents and informal discussions with geologists who are familiar with the Morrison deposit. Booker Gold staff have examined he surface exposures at Morrison, and currently are in the process of compiling and interpreting the geological data. The exploration programs on the two properties are designed to meet specific objectives, prioritized and planned to sequentially explore and evaluate the data for optimum control of the work programs.

Geologic procedures are being implemented to ensure systematic and controlled acquisition and processing of geologic data for the Hearne Hill and Morrison projects. The geological and technical staff are qualified to supervise the diamond drilling program and the sampling procedures, record relevant geological and geotechnical data, systematically organize and format the data to facilitate geological modeling of the deposits in preparation for resource estimations. A comprehensive quality control procedure will be in place with the objectives of checking the sample preparation procedures, and determining the accuracy and precision of the assaying procedures. Additionally, environmental baseline sampling program will be continued, and close liaison with regulatory authorities are being maintained. All information will be complied as received so that results can be disclosed in a timely manner.

Booker Gold engages three consulting geologists who regularly meet with Booker Gold's geological staff to review projects and provide guidance. Two of the three consultants are in a position to perform independent audits of the exploration procedures and results. A professional geostatistical consultant will be requested to undertake the geostatistical resource estimation.
