Referring to your letter of March 23rd.

We regret that Mr. DePencier's return to the Mine, mentioned in our letter of March 18th, was only for a day, during which time, he could not give your proposition due consideration. It was therefore necessary for us to let the matter stand until his return from the Company's Annual Meeting, Thursday last.

Mr. DePencier has decided to cooperate with you on the basis outlined in your letter of March 10th; this Company to send in its own engineers who will blanket the ore zone under your direction; you to supply a man with knowledge of the district to accompany him.

Dear Sirs:-Your paper of the 17th instant duly received. Before drawing up contract, I would like to make it clear that the man who will be sent by me to accompany your engineer will be paid by you at the rate of \$5.00 per day and expenses from the time he leaves Vancouver until hes return. It will not be necessary for you to keep him any longer than you wish after he takes you on to the ground, but as he is a very experienced person in making locations, it would be desirable to have him remain with you until all the locations are made and recorded. If you are inclined to send out another party on same terms as that already outlined, I would suggest that a second expedition be sent to the Francis Lake District, Yukon Territory through the Cassiar Country. There is great excitement in Cassiar at present and two thousand men are waiting now at Fort Wrangel, Alaska, to get up the Stikine River. I explored that district in 1897, at the time of the Yukon excitement, with seven men, and learned of a very valuable gold field, both placer and quartz, on Francis Lake which is approached through the Cassiar country which promises to be another Klondyke both as to Gold, and Silver-Lead deposits, like Mayo. The late Dr. George M. Dawson refers to it in his exploration of the Yukon District, in 1886-7, as follows:-"In general appearance the rocks of Francis Lake very closely ressemble those from which the rich gold deposits of Dease Lake, Cassiar District, are derived and they are probably of about the same age. Several colours to the pan were obtained from the mouth of Finlayson River which struck me as specially promising in aspect, and there seems to be no reason why some of the streams flowing across the schistose rocks into the lake or its vicinity should not prove to be richly auriferous. This entire district will deserves careful prospecting. After my return to the Coast in the autumn, I ascertained from Charles Monroe that he and some other miners had actually done some prospecting in the vicinity of the lake at the time when the Cassiar mines were yielding largely and the more enterprising men were scouring the country in search of new fields. He reached the lake from Cas iar by the same route we had followed. On camparing notes we found that he had worked for a short time at the mouth of the Finlayson, where he found the gravel to pay at the rate of from \$8 to \$9. a day.
