### Abbott Wagner – 43-101 Summary Report Received Summer 2006 Exploration Program

**June 29, 2006, Vancouver, BC – Golden Arch Resources Ltd.** is pleased to announce its intention to initiate a summer exploration program on its 100% owned Abbott Wagner property, which lies within the rocks of the Kootenay Arc, approximately 48 km southeast of the town of Trout Lake, BC.

In a recently compiled, 43-101-compliant summary report, the author, R. Somerville, P.Eng, states: “An historical published mineral resource of 327,000 tons grading 7.81% lead, 6.39% zinc and 295 grams per tonne silver (8.6 ounces per ton) is reported for this property.” However, he cautions that he has not conducted an independent verification of this resource, and therefore the reader should regard this only as interesting historical data, pending confirmation by an independent study. Mr. Somerville recommends a three-phase program to explore the property, including initial rehabilitation of the old mine workings and access road, re-sampling of known showings both on surface and underground, and bulk sampling of significant zones of mineralization.

The Abbott Wagner property has the potential to become a small, seasonal, medium to high-grade surface and underground producer. Silver, lead, zinc, and copper-bearing ore from sulphide-rich quartz veins and sulphide replacement pods in limestone will be direct shipped to the Teck-Cominco smelter. Minor gold and tin values previously found in ore in this district may also enhance the property’s potential.

A claim map will be posted on the Company’s website with this news release.

The recommended work program, has been designed to enable the commissioning of a full 43-101 report which will be completed as part of the overall program.

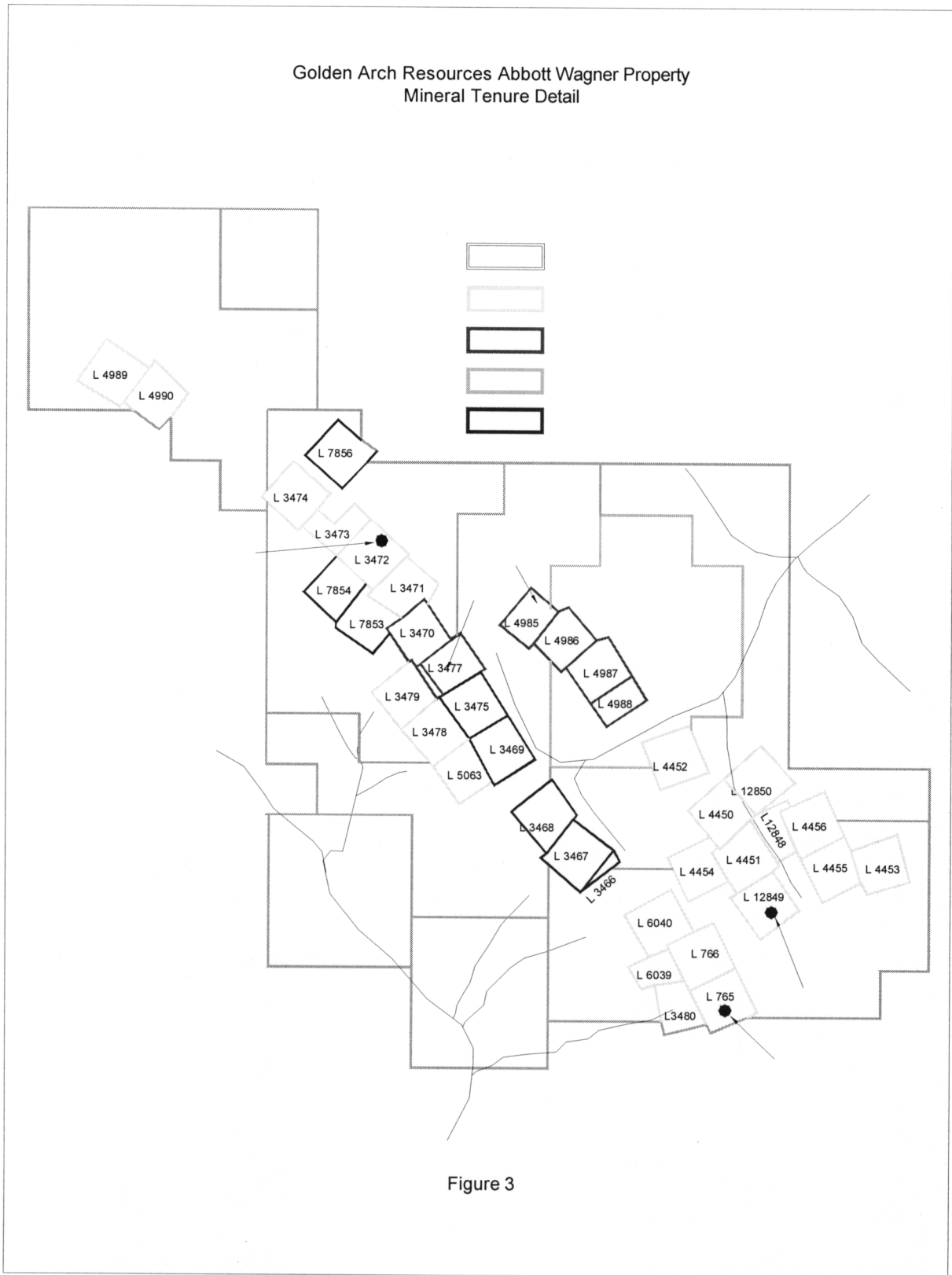
