**Mineral Exploration Activity:**

**Athelstan-Jackpot:** Linda Caron reports that the permitted trenching program on the Athelstan-Jackpot property will be underway this week to uncover a flat-lying, 1m thick, zone from which assays of up to 2-3 oz Au/t have been attained.

**Cool Vent/Yahk:** Klondike Gold have commenced deepening of a hole drilled last season on their Cool Vent/Yahk property to reach the LMC horizon.

**Howell:** Goldrea Resources have completed their first phase drill program on the Howell Property in the Flathead drainage which comprised 1075m in 3 holes. The core is currently being spit and sampled. Results of the airborne geophysical survey flown over the property last month have just been received and are being reviewed. Work on the adjacent Crowsnest property is planned to commence in early September. A University of Alberta professor and graduate student recently visited the property to collect samples of the Howell Creek intrusive suite for trace element analysis and isotopic dating.

**Kena:** Sultan Minerals have temporarily ceased drilling to await assays and to raise further money. To date this year 24 holes have been drilled on the Gold Mountain Zone, Great Western, and Starlight prospects. No results of the drilling have been released to date. As well a significant amount of IP surveying was carried out. Resumption of drilling is planned for mid-late September pending financing.

**Silver Lynx:** Cassidy Gold Corp. has entered an option agreement with Delta Exploration Inc. whereby Delta can earn a 50%-60% interest in the Silver Lynx VMS Property southwest of Nelson by making share and cash payments and meeting expenditure obligations. **Vowell Creek:** Field work comprising soil sampling, geological, and structural mapping is currently being carried out by Jasper Mining Corp. on its wholly-owned Vowell Creek property which covers the past producing Ruth Vermont mine. It is anticipated that a drill program will commence in late September or early October.

**Ward Cu-Au:** Jonpol Explorations have completed the previously announced trenching program on the Ward Cu-Au property east of Beaverdell. Drilling testing is planned to commence in early September.

**Regional Geologist Activity:**

**Mineral Exploration Activity:**

**Athelstan-Jackpot:** Sampling has been completed of a series of trenches on the A-J property in the Greenwood camp. The aim of the program was to establish the gold grade and dimensions of a zone of oxide material related to discontinuous zones of sulphide mineralization hosted by a listwanite zone in the flat-lying Lynn Creek thrust fault. Gold grades of up to 3 oz/t Au have been attained from samples of the oxide material, which in one trench was up to 3m thick. The trenching was carried out adjacent to the past-producing Athelstan Mine in an area of previous exploration trenching.

**Cold Creek:** Klondike Gold is continuing to deepen a hole drilled by Minova (MM91-01) to a depth of 425m on the Cold Creek property, located 3-4km east of Yahk . It is expected that the LMC should be intersected at a depth of approximately 1000m in in the hole.

**Crowsnest/Howell:** Goldrea Resources reports that drillsites are now being constructed on the Crowsnest property in the Flathead area where trenching in 1999 exposed a mineralized zone assaying 8.6 g/t Au over 16.5m in syenite intrusive and limestone. Results from the recently completed drill program on the adjacent Howell property are expected shortly.

**Moyie West Block:** Klondike Gold have commenced deepening of hole K97-2 which was drilled in 1997 by Kennecott to test a large gravity anomaly in an area underlain by Middle Aldridge Fm rocks. The hole intersected a 190m thick Moyie sill which Kennecott believed explained the gravity anomaly and the hole was terminated approximately 600m before reaching the LMC. Only two holes have been drilled in the area to the LMC (Sullivan time) in the past, despite numerous indicators of Proterozoic aged structures and alteration in the Moyie West Block. Hole SMC95-1, 7km to the north, intersected 17m of pyrrhotite mineralization with visible sphalerite at the LMC and K97-3, drilled 3km to the east in the Panda Basin, intersected significant alteration and fragmental development at the LMC and a sulphide vein in the overlying Middle Aldridge which assayed 5.82% Pb, 9.63% Zn, and 49.4 g/t Ag across 2.35m. Three other targets in the Moyie West Block are planned for drill testing by Klondike this season. In addition drilling is planned on the nearby Gerry Vent Sullivan-type target and Thea 17 high-grade gold zone.

**Mineral Exploration Activity:**

**AuByrd:** Solitaire Minerals is planning to commence surface exploration on its AuByrd property in the Flathead area before the end of July. The work will include surface Mag surveying, prospecting, and stream sediment sampling.

*ACW* **Athelison-Jackpot:** A NoW has been received for 150m of new trenching and cleaning out of 80m of previous trenching on the Athelison-Jackpot property, located NW of Grand Forks.

*2* **Howell/Crowsnest:** Goldrea Resources Corp. has announced that it will be contracting Fugro Airborne Surveys to fly 150 line kilometres along 200 metre spaced flight lines with helicopter-borne magnetic and radiometric surveys on its Howell Au property in the Flathead area. The airborne survey, scheduled to be completed in the next week, will be followed up by drilling. Goldrea will carry out a program of mapping, trenching, and drilling on the Crowsnest property, slated to commence in late August.

**Kena:** Sultan Minerals have been carrying out a field program over the last month comprising, geological mapping, IP surveying, soil sampling, and chip sampling on the Kena Project. Drilling will be commencing soon and the program is expected to continue until late September under the currently approved budget.

**Lone Peak:** Golconda Resources are currently drilling hole 3 from the pad on top of Lone Peak. Holes 1 and 2 from the setup were 400' and 200' while the current hole is expected to be approximately 1000' in length and is targeting the Spar Lake quartzite horizon. No results are available from the drilling carried out to date from this setup.

**Ward:** Jonpol Explorations has carried out a soil sampling program on its Ward Cu-Au property in the Beaverdell area. A trenching program will be carried out to follow up on anomalous results from the geochem survey.
