EXPLORATION MONITORING

Eastfield Resources and JV partner, Imperial Metals, plan to resume Beekeeper. drilling on the Au-Cu porphyry prospect, 22 km southeast of Mount Polley, in March. Drill targets include a high grade zone intercepted in 1996 drilling (22 metres grading 0.96 gpt Au and 0.70% Cu) and a large Cu-Au geochem anomaly. addition, geophysics will be conducted over a large area of prospective geology within claim boundaries.

Clear Creek Resources plans to conduct a \$200,000 diamond drilling and geophysical surveying program on the Indata Cu-Au porphyry prospect (under option from Eastfield Resources), northwest of Tchentlo Lake. 11,270 Kg [362,340 02.)

AGC Americas Gold Corp. has released a revised geological resource for the central Finn zone, JD property in the Toodoggone, of 3.52 million tonnes grading 3.22 gptAu. This higher grade zone sits within a larger resource of 9.36 million tonnes grading 1.61 gpt Au. No cutoff grades were provided. In 1997, AGC plans to continue exploring the property for additional bulk mineable tonnage by drilling off possible extensions of the Finn zone to the north (EOS zone) and west (Ag-carbonate zone). However, the comapanys exploration budget has not yet been approved by management.

Lloyd Nordick. Big Valley Resources has released a preliminary resource estimate for the Lloyd 2 deposit, located immediately north of the Mount Polley mine development. A measured-indicated resource of 2.5 million tonnes grading 0.546% Cu and 0.391 gpt Au, at a cutoff grade of 0.20% has been estimated for the zone based on 25 metre drill spacing completed last year. The tabular-shaped deposit has a northeasterly trend, dips steeply and is open on 3 sides. Additional drilling is planned for early 1997. Bulk sampling is also planned in order to conduct bench scale metallurgical test work.

Spokane Resources plans to recommence drilling at their Mo-Cu porphyry prospect, 100 km north of Endako, in early March.

Welbar. Gold City Mining is planning to return to the Wells area to renew exploration on its considerable land holdings, assuming it gets its financial house in order. The company has recently optioned the Domin property and has added it to its stable of properties in the area. If sufficient tonnage can be proven among several (small) high-grade gold prospects, Gold City will proceed

EXPLORATION MONITORING

QR. Exploration at the mine site has been completed for the year. A summary will be provided in Octobers monthly report.

Gibraltar. Westmin Resources Limiteds take-over of Gibraltar Mines Limited is almost complete. Westmin, through its wholly-owned subsidiary, WRL Acquisition Corp., has acquired over 92% of the issued and outstanding common shares of Gibraltar.

Akie. Eleven diamond holes totaling 4982.6 metres were drilled this summer by Inmet Mining with mixed results. Rumour has it that Inmet will be dropping its option on the property.

Beekeeper. Joint-venture partners Eastfield Resources (operator) and Imperial Metals have completed an 11-hole, 1300-metre diamond drill program on their alkalic porphyryAu-Cu target located north of Horsefly.

Joh. Diamond drilling on the Pacific Sugar zone, a copper-gold magnetite skarn showing located in rugged terrane south of Darb Lake, has been completed. Joint venture partners by International Conquest Resources and Major General Resources are currently reviewing assay results.

Mariposite. Catalyst Ventures reports that drilling by Battle Mountain Gold on their joint venture project has been shut down because of early winter-like conditions. One hole was completed and assay results have not been reported.

Mac. Diamond drilling on the Peak zone has encountered copper and moly mineralization in intensely altered porphyritic intrusion. Assays are not yet available. The Peak zone is the southern of three distinct zones that comprise the Mac porphyry system (the third zone is the Trail). It has a geophysical signature measuring 1 km north by 0.5 km east. Three additional holes will be drilled on the Peak zone, before the drill moves on to the east margin of the Camp zone.
