We did stake some claims between PG and WL. There are 2 claim groups BH (Baldy Hughes) and C&M (dunno what that stands for and we haven't given the project a name yet). Since there is excessive glacial cover we think the progressive approach is to get an RC or OVB rig and poke some holes at various intervals along the logging road network but I don't have a big budget for this and wont make a real decision to do anything until we get on the ground there and get a better feel for things.
