Subject: Weekly Report - Nov. 6th/98

- As of yesterday AM, Rick Walker reported that 8 souls had registered for the Industrial Minerals Workshop to be held here in Cranbrook over the next three days. The course will go ahead with lectures on Saturday and field visits on Sunday & Monday. I'll be sitting in on the lectures and helping with the field activities.

- Miner River Resources has issued a press release reporting that Kennecott has completed a program of five drill holes totalling 1853 metres at the Findlay property 35 km NW of the Sullivan mine. "The most significant mineralization" was encountered in hole #5 near Tourmalinite Ridge. "Laboratory analyses of drill core (type, grade and extent of mineralization) are expected to be completed by the end of November." It's further reported that Kennecott staked 46 contiguous claim units over prospective formations adjoining the property SUBSEQUENT TO COMPLETION OF DRILLING. (Read between the lines folks!).

- On the Irishman property Kennecott limited its drilling to a 340 metre extension of the 3rd hole of the 1997 program in which a 2.5 metre intersection of high grade massive sulphides had been intersected. The objective of the '98 drilling was to test a re-interpreted position of the Sullivan horizon. Results have not been reported but Kennecott is dropping its interest in the property.

- Abitibi Mining Corp. has announced plans to start drilling immediately at the Clair property (optioned from Cominco) about 20 km west of Kimberley. A 2000 foot hole is planned to test the Sullivan horizon. Drilling will then move to its Yahk property where a program of three holes totalling 7500 feet is planned.

- Ascot Resources has cut back on its drill program at the "Smoker vent" prospect west of Moyie Lake. Two short holes will be attempted this year with a longer hole to follow in the spring. 100% interest in the property has now been acquired from the "Supergroup" (Pighin, Anderson, Klewchuk, and Craig Kennedy & sons).

- (All of the above programs are targeting Sullivan type sedex mineralization).

Kaslo Silver
 - Cream Minerals has acquired some additional funding for its Kaslo Silver high-grade Ag/Pb/Zn prospect on Keen Creek and will resume drilling at the Bismark and Cork South zones next week. It has also applied for a permit to recover 500 tonnes of heavily mineralized broken ore located below the Province mine workings, to be processed through the soon-to-be-permitted Ainsworth mill.

Blu Star
 - In the Slocan Valley, Anglo Swiss has announced discovery of a new sapphire showing, called Sapphire Hill, very close to the Blu Moon sapphire showing. Hand processing of a 20 kg boulder apparently yielded an incredible 5000 carats of good quality crystals, most displaying strong asterism (i.e. star sapphires). Early indications are that this discovery could triple the company's total sapphire resources. Samples are being shipped to Sri Lanka for heat treatment testing.

Placer
 - Also in the Slocan Valley, I collected three buckets of Slocan River gravels from three widely spaced sites on claims adjoining Anglo Swiss's sapphire property where two individuals report finding several large rubies. Apparently there is a remarkable transition occurring right at the claim boundary between the two properties whereby the corundum crystals are all sapphires on one side and all rubies on the other! The ruby finders have

Regional Geologist Activity:

- Visit to Jubilee Mountain barite Mine
- Visit to Lone Peak property, prospector Brian Kostiuk
- Visit to Supergroup Holdings office at Moyie

Prospectors Assistance Program:

Peter Klewchuck has commenced preliminary work on his gold property in the Perry Creek area and his magnesite property northwest of Radium Hot Springs.

Mineral Exploration Activity:

Black Crystal: Crystal Graphite Corporation reports that it has completed construction of its flake graphite pilot plant in the Slocan Valley. The ongoing exploration program comprising drilling and trenching is expected to be completed by mid-August.

Blue Starr: Hampton Court Resources has informed me that it is likely no exploration work will be carried out on the Blue Starr property this year due to ongoing negotiations with their JV partner, Anglo Swiss Resources Inc.

Ice: Skeena Resources Ltd. is planning on commencing drilling on the Ice kimberlite prospect near Elkford in early to mid August.

Jubilee Mountain: Tiger Ridge Resources Ltd. is moving forward with mining and exploration work at its Jubilee Mountain barite project west of Spillimacheen. Underground development is continuing in both the Heli and Grizzly adits. An ore stockpile containing approximately 5000 tonnes of barite is waiting completion of the onsite jig concentrator for processing. Surface exploration drilling is being carried out on the Nose zone and twelve short holes have been completed to date.

Kena Gold: Sultan Minerals Inc. have reported results from drill hole 6, drilled parallel to and 50m grid south of holes 1-3, from their recently completed drill program on the Gold Mountain Zone. The entire drillhole was mineralized averaging 0.62 g/t Au over 124m including 26m assaying 1.01 g/t Au and 32m assaying 1.20 g/t Au. Three 2m intervals gave higher grades of 3.59 g/t Au, 5.11 g/t Au, and 9.08 g/t Au. Results from hole 7, located 300m south of holes 1-3 are pending.

Silver Lynx: Cassidy Gold Corp. reports that it has recently completed TEM, soil, and geological mapping surveys on its Silver Lynx VMS property west of Nelson. The results from this work warrant a drill program. A notice of work has been submitted and financing is currently being arranged.

(ASW - Montreal) is pleased to announce that in conjunction with its joint venture partner, Hampton Court Resources Inc., (the "Optionors"), have entered into a Mineral Property Option Agreement, (the "Option") with Crystal Graphite Corporation the ("Optionee"). Anglo Swiss Resources and Hampton Court have granted Crystal Graphite the right to acquire a registered interest from the Optionors to mine, extract and process any and all graphite material on certain of their property in the Slocan Valley, British Columbia, known as the Blu Starr Gemstone property.

Prospectors Assistance Grantees:

- Ed* • **Ed McCrossan (P.35):** Ed visited the office on September 29, and has staked a 20 unit parcel called the Queen Property, located south of Quatsino Sound in N. Vancouver Island; he is targeting primarily epithermal gold-silver, but also skarns and porphyries, with phase 2 prospecting currently in progress.
- Blu Star* • **Jim Laird (P.55):** Jim is still working full-time in the Nelson area on gemstone exploration for a client/employer (with considerable success he reports), and has completed some assessment work to maintain Vancouver Island properties, but has not yet commenced the Frasergem 2000 PAP project; he may need to allocate the late field season to the Seaview 2000 PAP project, or possibly relinquish grant if no time remains.
- PGE's Mascot - Grand play* • **Murray McClaren (P.11):** Visit completed Lake on October 5 to Murray's revised project area near Harrison Lake, where he has located an extensive (100 m. wide) variably mineralized pyroxenite zone in a logging road cut, consisting of sheared pyroxenite with up to 10% sulphides including 1-2% chalcopyrite and bornite; this area is located just beyond the recent extensive staking by Nicholson and Associates; new staking by Murray is in progress, with analyses for Cu-Ni-PGE's pending, and maybe a new minfile occurrence!
- **David Haughton (P.7):** Joint visit completed October 6 with David, as well as Neil Church, Tom Schroeter and Robert Pinsent, to Homestake's Giant Mascot past producer of Cu-Ni-Pt-Pd-Au-Ag; spectacular mineralized samples were obtained from the old dumps near the mill, and from talus near an old adit; this visit was very helpful to help understand the gabbroic Cu-Ni-PGE deposit model, that knowledge to be applied to projects of other clients, such as McClaren, Arne Birkeland (Tofino Nickel), Mikkel Schau (Mt. Hall, Schoen Lake) and Efrem Specogna (Kitkat and Dragon).
- **Anton Nijhuis (P.71):** Anton reports little success in N. Vancouver Island, so is concentrating prospecting efforts in the Central Island area closer to home in Campbell River; he has staked 2 claims near the Oyster River targeting a high quality building/landscape limestone deposit.

Other Clients:

- New Discovery* • **Jeff Bucov (Leech River, S. Vancouver Island):** Reported discovery of bedrock samples containing up to 20% sulphides in silicified diorite intruding Leech River Schists upstream of his gold placer claims; assays pending, along with site visit planned for late October.
- Raven Texada Is.* • **Cream Minerals' Raven Property (Nootka Island, W. Van. Isle):** Airborne geophysical survey recently completed over this VMS target property staked in 2000 to cover Sicker Group volcanics.
- **555 Corporate Ventures (Texada Island):** Visit completed with Tom Schroeter, and prospecting team of Daryl Clark, Bob Duker & George Martin, to the Bolivar Mill and Yew Pit (neither operating) on Oct. 3; of interest is the presence of 15-25 barrels of assumed mill concentrate product in the yard behind the mill.
- **Daryl Clark and Bob Duker (Texada Island):** Visit completed on October 4 with those above to the **Tak Property**, site of the pending bulk sample for testing gold values in a wide zone of volcanic-hosted quartz-carbonate-sulphide veins; visit also completed on October 4 to the **Dude Property**, recently staked porphyry copper-gold-moly target along the north-central coast of Texada Island, where extensive areas of sheared and variably mineralized quartz diorite (mainly shear-hosted pyrite with minor chalcopyrite and bornite) was previously explored by Falconbridge, and exposed by roadcuts; samples were taken and sent for analyses, and Falconbridge data in the Vancouver MDO will be made available to the prospecting team on Texada.
- **Jack Rauhala (Seymour Inlet, Central Coast):** Cowichan Bay - based sailer/pro prospector is targeting gold deposits in the Seymour Inlet area, and marketing Cu-Ni-PGE properties in the Sudbury area as well.

- visited Coyote Creek project (NTS 82J/3W) of Eagle Plains Resources Ltd. on June 14th. This is the first drill test of Devonian black shales believed to be the source of highly anomalous, multi-element, RGS data. Four creeks draining the Coyote Pass between Coyote Creek and Lussier River, measured in the 99th percentile for zinc, the highest number being 5550 ppm Zn. All four samples were also very anomalous in nickel, vanadium, and molybdenum. The company's plan was to drill two 300m holes at two widely separated sites to transect and sample the shale package, which is recessive and difficult to map or prospect on surface. At the time of my visit, they had aborted the first hole at a depth of 153m after getting into a badly faulted zone which the drill had been unable to penetrate. The drill was being moved to a second location nearby and deeper in the stratigraphy. The first hole had collared in the shale and penetrated a continuous section of thin-bedded, calcareous, black shale and siltstone with several conformable thin seams of pyrite/marcasite and abundant, but unidentifiable, disseminated sulphides. It will require analysis to determine what minerals or metals are present. The company is thinking sedex but there are many similarities to the Nick massive sulphide in Yukon.

Foot

- visited briefly in the AM of June 15th with Steve Butrenchuk who is looking after Westroc's drilling program at its Kootenay West/East gypsum property on the Kootenay River northeast of Canal Flats. They completed 29 holes (total ~1100m²) on the west side of the river and were on the second hole of about 20 planned for the east side. The gypsum resource on the west side (large!) has apparently been fairly well blocked out now, but the size and quality of the resource on the east side is poorly known.

- Rod Luchansky (co-discoverer of sapphires in the Slokan Valley) phoned this morning to report that Hampton Court Resources, which has optioned all of the Anglo Swiss gemstone holdings is making its first appearance in the field today. They are talking about a \$250,000 initial expenditure this year. Meanwhile Rod claims that he and his partners are continuing to identify new gemstone occurrences in various parts of the West Kootenays.

- Glen Rodgers reports that Abitibi Mining Corp. is preparing to initiate its drilling at American Creek on the Canam property southeast of Yahk (optioned from Cominco). He feels that the Sullivan horizon has been accurately identified by Doug Anderson on surface in earlier Cominco work and will be the target of their drilling.

- Rio Algom is drilling on the South Findlay property and is believed to be about half way through the planned 2000m, 3-hole program.

- Attended Barry Ryan's annual coal symposium in Sparwood on the evening of the 15th, and presented my usual talk on non-coal exploration activity in the region. As always, Barry had done a superb job of organizing the event and arranging some high-profile speakers on a number of interesting topics (zero-emission coal, coal-bed methane, the oil sands, selenium in coal). The turnout was down to ~30 instead of the usual ~40. Most noticeable to me was the absence of the usual group of enthusiastic summer students. Apparently, in these tough times, the coal mines are employing few, if any, co-op or summer students. What future has the mining industry if it can't find a way to help train the next generation of professionals?

- Have communicated with all but one of the six successful PAP grantees and a couple of the unsuccessful ones. Frank Renaudat and Bruce Doyle have already started work on their programs, with early hints of success in both cases.
