- **Boliden Asset Dispersal Continues:** Boliden Ltd. continued dispersing assets for much-needed cash with the Feb. 28 announcement of the sale of its South American interests (Lomas Bayas and Fortuna de Cobra) to Noranda and Falconbridge; at the Myra Falls Operation, a concentrate-sale funding arrangement is pending with Dowa Mining to help with minesite capital projects; the Myra Falls Operation is also closing its Campbell River Exploration Office effective Monday, March 5, 2001, signifying an end to regional exploration efforts on Vancouver Island by the Boliden group.
- **SYMC Mctush Dauntless Cu Project, Port Alberni:** Visited Dauntless prospect (092F 168) on Feb. 26 with Herbert McMaster, Jr., accessing via barge from Port Alberni; two adits and rock dumps visited and a selected grab sample of sheared chalcopyrite-bearing vein material was taken from the footwall of the upper adit, with the sample retained for possible future analyses; dumps inspected, but badly overgrown and difficult to evaluate for size and mineralization content; access issues being negotiated with Weyerhaeuser and the Port Authority; tenure issues (E&N Land) for base metals being investigated by Weyerhaeuser; SYMC plans to mine the rock dumps and barge/truck the material to Boliden's Myra Falls Operation to generate revenue.
- **Beau Pre Valentine Mountain Au Project, Sooke Area:** Press release issued by Beau Pre on Feb.23 regarding status of Valentine Mountain Project (Minfile 092B 108, -075); drill core assaying from the late 2000 program is reported as being underway, but verbal reports from Mr. Beau Pre indicated no ore-grade intercepts were obtained; bulk samples from C and B veins at Discovery Zone blasted in late 2000 are planned to be test-milled on-site using First American's KDS Micronex machine currently under construction in Vancouver, pending permitting.
- **Mikkel Schau Vancouver Island PGE Exploration Projects:** Visit made by 2000 PAP grantee to discuss geological concepts and exploration plans relating primarily to PGE targets, but also porphyry copper, copper skarn, and epithermal gold targets, following up positive and interesting results from his 2000 programs.
- **Lew Knott Gaffer Au Project, Port Renfrew Area:** Results received from outcrop grab samples of quartz-pyrite-biotite veins in amphibolite-schist from February 15 sampling; sub-anomalous values received for metals and indicator elements; client notified.
- **Gary Pearson Galleon Project, Port Renfrew Area:** Contact received from Gary regarding conceptual project targeting PGE's in the Port Renfrew area (sensitive and confidential); previous sponsorship by Boliden has been recently terminated; tentative visit planned for April to review concepts and exploration methodology.
- **Derrick Hamilton Rocky 10 Dimension Stone Project, Jordan River Area:** Contact received from Derrick regarding quartzite/quartz? Dimension stone property near Jordan River; tentative visit planned for April.

Ministry Projects:

- **Mining and Exploration in British Columbia - 2000:** Southwest Region report completed and edited and forwarded to Dorthe Jakobsen for desktopping; quotations (3) received from Nanaimo-based printers, and comparative analysis completed and forwarded to communications / Queen's Printers to seek approval for local printing; desktopping by Dorthe using MSPublisher in progress pending very demanding short term schedule for Regional Planning Geologist.

Industry Activity:

- **Emerald Field Resources Port Renfrew/Jordan River Area Pearson Cu-Ni-PGE Project Update:** Contact established with Perry Heatherington, Chief Operating Officer of Emerald Field Resources, who have negotiated an option agreement with Gary Pearson and have completed staking Cu-Ni-PGE targets in two separate target areas: map sheets 092C055,-068,-069 (in Wrangellia north of Port Renfrew) and 092C050 (in Crescent Terrain near Jordan River); soil geochemistry (using MMI) and rock geochemistry reconnaissance sampling programs are in progress, and muscovite age dating, petrographic work and preliminary metallurgical testing from initial samples are being completed; airborne geophysics and possible drilling is also planned for 2002, with a preliminary budget of \$500,000; Emerald Field is establishing registration in B.C. and a corporate FMC to work and hold claims in the province, and looking to work with technical expertise in B.C.; local geological consultant and PGE expert Mikkel Schau was referred to Emerald Field to assist them, and the concept of partnerships with the G.S.B. was suggested to Mr. Heatherington; he was also invited to visit the Nanaimo office in advance of submitting possible Notice of Work applications.
- **Saxony Explorations Klinaklini River Area Redbreast Project Porphyry Cu-Mo-Au Project Update:** Contact established with Addrian Hobkirk of Saxony Exploration, who have negotiated an option agreement with Dauntless Development and Metamin Enterprises for 3 separate claim blocks totaling 207 units and covering 4 MINFILE occurrences: Hannah 8,10,11 (092N028), Hoodoo North (092N029), Lancers Mountain (092N051) and Darlene (092N063); prospecting and geochemistry is planned for this summer, with a preliminary budget of \$50,000; thanks to Tom Schroeter for the heads-up on this project; Saxony is seeking new Au-Ag opportunities in B.C., so compilation documents on gold opportunities in the Southwest Region were sent to Mr. Hobkirk.
- **Clearview Minerals / Rudy Riepe Sechelt Area Mineral Hill / Sechelt Carbonate Wollastonite/Garnet & Zn/Cu Skarn Projects Update:** Site visit planned on August 12-13 with Rudy Riepe to review results and core from major drilling project completed earlier in the year on Clearview's Mineral Hill Wollastonite/Garnet Skarn Project (MINFILE's 092GNW052,-053), and to review new prospecting results on Mr. Riepe's Sechelt Carbonate Zn/Cu Skarn Project (MINFILE's 092GNW031,-035,-048).

Government/Ministry Activity:

- **GSB Mineral Deposit Profile Review for PGE-bearing Mineral Deposits:** Collaboration begun with North Vancouver-based geological consultant Murray McClaren to establish an appropriate mineral deposit profile for B.C. to capture the Giant Mascot Cu-Ni-PGE deposits in the Harrison Lake area, probably based on one or more of the USGS Mineral Deposit Models; this work may also set the stage to establish a profile for deposits in the Port Renfrew/Jordan River area once more information is known about them as well; interaction with G.S.B. personnel, particularly Graham Nixon, will be essential.
- **GSB Bella Coola Area Regional Geochemical Survey (RGS) Data Release August 14:** Plans made for J. Houle to be in the Vancouver M.D.O. (Tom Schroeter away on field visits) on August 14 to assist clients with any technical questions related to the Bella Coola RGS release scheduled for 1:30 pm, August 14, in transit from field visits in the Sechelt area August 12-13; J. Houle will be in the Nanaimo Office on August 15 to assist clients if necessary, but it is assumed that most client activity related to the release will be at the M.D.O., and telephone contact will be available on August 14 all day as well.
- **Southwest Region Assessment Report Relocation Project Update:** Quotes received for relocating assessment files from Burnaby to Nanaimo (~\$350-450) from trucking/courier companies; Release of reports by Iron Mountain

Industry Activity:

- **Javorsky Port Alberni Area Tay Au Project Update:** Dalmation Resources allowed the Tay Property near Port Alberni to lapse in April, which covered 4 MINFILE occurrences, including the Tay developed prospect (092F212) with mineral inventory of 132,255 tonnes @ 2.15 g/t Au in Cu-Ag quartz veins; it was subsequently restaked in part by prospector David Javorsky.
- **Pearson Port Renfrew Area Galleon Au/PGE Project Update:** Litigation matter initiated by former partners dismissed by courts; plans made to visit prospector Gary Pearson's PGE project area, including on May 9 (note: GSB tourists welcome!)
- **Priority Courtenay Area Dove Creek CBM Project Update:** Private placement funding of \$1.1 million raised for drilling up to 4 "coalbed gas wells"; one well successfully completed, with drilling of the second well to commence in June.
- **Leader Hope Area Cogburn Mg Project Update:** Leader Mining has filed the Pre-Application Report for the Cogburn Magnesium Project to the BC Environmental Assessment Office; visit planned to Cogburn with Tom Schroeter on May 7.
- **Halliday Hope Area Spanky Cu-Ni-PGE Project Update:** Additional staking completed by prospector Murray Halliday in 2002 to increase property to 52 units; plans made to visit Murray in Hope subsequent to the Cogburn visit on May 7.

Government/Ministry Activity:

- **Southwest Region Assessment Reports Status Update:** Intention established by the Regional Manager to relocate the 101 boxes of assessment reports from Iron Mountain file storage in Burnaby to the Nanaimo Mines Branch Office; costs savings over time and increased accessibility for staff and clients will be achieved.
- **Southwest B.C. Property Listing Update:** Progress made on S.W. Region property listing, continuing map sheet 092H; remaining mapsheets are 092I,-J,-M,-N,093C,-D,103A; the Harrison Lake area on map sheet 092H is still in a dynamic staking rush, with over 700 units staked to date in 2002, bringing the cumulative staking to date since 2000 to about 3000 units.

Industry Activity:

- **2002 Activity Forecast for Southwest Region:** Revised activity forecast for Southwest Region issued to Tom Schroeter for compilation with other regions, is summarized as follows:
 - 22 projects with expenditure estimates totaling \$3.24 million, including 10 major projects >\$100,000
 - 4 conditional projects with expenditure estimates totaling \$2.62 million, including 3 major projects
 - 26 projects in total with \$5.86 million combined expenditures including 13 major projects, compared to \$3.5 million and 8 major projects in 2001
 - 9 additional undefined projects with unknown budgets not included, but should bring total expenditures to about \$6 million
- **Garry Pearson/Emerald Field Resources Port Renfrew Area Cu-Ni-PGE Project Update:** Additional staking activity noted in Mineral Title System with recent claims not yet posted on MapPlace, now totaling 45 claims and 634 units on map sheets 092C050, 059, 068, 069; contact with Perry Heatherington of Emerald Field Resources still pending, but email sent through their website link to establish contact.
- **SYMC Port Alberni Area Macktush/Dauntless Au-Ag-Cu Project Update:** Site visit completed with SYMC president Herb McMaster on July 30 to 3 recently prospected target areas exposed in logging road cuts on the Macktush/Dauntless project: MC prospect (MINFILE 092F103 as Kola), Pyrite Porphyry Zone (surrounds Rex MINFILE 092F221), and Bowl Zone (near Macktush 092F012); photos and 7 mineralized grab samples taken for description and possible analyses; MC (pronounced "mick") occurrence is similar to the Dauntless, and consists of multiple, sheared massive sulphide (chalcopyrite, bornite and pyrite) pods in Triassic Karmutson basalt; the Pyrite Porphyry Zone consists of a 1.5 km x 1.5 km area of pervasive silica-clay-pyrite altered volcanics that look like they could be of the Jurassic Bonanza Group?, containing occasional chalcopyrite-bornite stockwork mineralization; the volcanics are cut by numerous barren quartz feldspar porphyry dikes; this is a large Porphyry Cu-Mo-Au target; the Bowl Zone is another Porphyry Cu-Mo-Au target exposed by new logging roads, and mineralization consists of quartz-chalcopyrite and/or quartz-magnetite stockwork straddling the contact between Karmutson basalt and Jurassic granodiorite.
- **Newmex Zeballos Area Privateer Au-Ag-Cu Project Update:** Editing completed on behalf of Reno-based consultant Randy Henkle working for Newmex Minerals, on Zeballos Project Summary Report, with some improvements suggested.
- **Stellar Stone Inc. Whistler Area Jimbo 2 Dimension Stone Project:** Jim Cairns of Stellar Stone reports plans to file a notice of work in August to complete access to and extract a bulk sample of both talus and bedrock sources of basalt on the Jimbo 2 claim (092J03E) in the fall; Jim is also looking for sources of clean, unfractured dacite (probably any felsic volcanic will do).
- **McClaren/Metcalf Sable (MINFILE 092HNW076) and Katt Harrison Lake Area Cu-Ni-PGE Projects Update:** Prospecting geologists Murray McClaren and Paul Metcalf have been busy consulting in B.C., but in their spare time are looking at the regional setting of their 2000/2001 Cu-Ni-PGE discoveries, and analogous economic mineral deposits elsewhere in the world, with some success; new ideas are required to rejuvenate magmatic PGE exploration activity in the Harrison Lake area.

- **Preliminary 2002 Activity Forecast for Southwest Region:** Initial tally of 2002 exploration project expenditures in the Southwest Region is about \$6.5 million, including 10 major projects >\$100,000 each, compared with \$3.5 million and 8 major projects in 2001; however, the 2002 forecast includes \$2 million for 2 projects for which funding is pending, plus \$1.2 million for 2 coal bed methane and/or coal exploration projects; placer projects (few and all small) and sand and gravel projects (many and poorly documented) are not considered in the forecast; Myra Falls is forecasting nil exploration expenditures for 2002.
- **Beau Pre Explorations/First American Scientific Sooke Area Valentine Mountain Au-Ag Project Update:** Pending completion and acceptance of permit requirements, upgrading and installation of the Micronex 40 tpd mill on site is planned over the next few week to process up to 5000 tonnes of Au-Ag bearing quartz vein material from surface trenches at the Valentine Mountain (MINFILE 092B012) project; expenditures of \$100,000 are planned for 2002 in this project.
- **Garry Pearson/Emerald Field Resources Port Renfrew Area Nabay/Ran/Ultra Cu-Ni-PGE Project Update:** In late June, Emerald Field Resources of Kenora, Ontario completed an option agreement with Garry Pearson of Port Renfrew and Perry Heatherington of Emerald Field recorded 343 units in 25, 4-post mineral claims to surround Garry's existing 2-post claims as of June 29; Emerald Field's plans for 2002 are not known at this time, but contact is expected from Perry soon (presumably when he has completed staking); geochemical results were received from sampling of sulphide mineralization hosted by intrusive rocks on his Princess claim (near Sirdar MINFILE 092C025) and Tod 2 claim (near Reko 3 MINFILE 092C090) yielded up to 3%Cu, 4g/tAg, 595ppmNi, 1709ppmCo, 372ppbAu, 2619ppbHg and 72ppbPd.
- **SYMC Port Alberni Area Mactush/Dauntless Au-Ag-Cu Project Update:** Nanoose-based consulting geologist David Pawliuk completed a property summary report to 43-101 standards (at long last) for the Mactush (MINFILE 092F012) and Dauntless (MINFILE 092F168) properties, the results for which were issued in a press release of July 12; at Mactush, undiluted inferred resources for the Fred Vein are 182,982 tons @ 0.695%Cu, 1.42optAg, and 0.36optAu; and for the David Vein are 59,524 tons @ 1.02%Cu, 1.76optAg and 0.47optAu; both are steeply dipping and planar quartz-calcite-sulphide veins 1-2 meters thick that may be amenable to narrow vein longhole mining methods; at Dauntless, undiluted inferred resources for one of the several chalcopyrite-calcite veins are 27,750 tonnes @ 22.3%Cu; further prospecting is planned for Mactush in 2002 (\$20,000) and trenching/bulk sampling is planned for Dauntless (\$80,000); a property visit to Dauntless and possibly Mactush with SYMC president Herb McMaster is planned for July 30.
- **Priority Ventures Courtenay Area Dove Creek CBM/Coal JV Project Update:** Priority is finalizing a joint venture agreement with an Alberta-based company for exploration and development of the Dove Creek project; this will include a \$1 million, 3 hole drilling program targeting primarily CBM potential; Priority has also acquired 5000 acres surrounding the former Suquash Coal Mine (MINFILE 092L067) near Port McNeil, and is planning a \$160,000, 3 hole coal and/or CBM drilling program this winter.
- **Hillsborough/Texas Canadian Ventures Campbell River Area CBM/Coal JV Project Update:** Lubbock, Texas based Texas Canadian Ventures Inc. completed a joint ventures agreement with Hillsborough Resources to evaluate and develop Hillsborough's Campbell River area coal deposits as per a press release of July 3; the Quinsam Airport/East project (MINFILE 092F319) is expected to see \$500,000 in expenditures in 2002, including a 5 hole, 2000m. exploration drilling program targeting both CBM and coal; at T'Sable River, Hillsborough is planning a \$1 million, 18 hole Coal/CBM exploration program on the northern portion of the T'Sable River project (MINFILE 092F333) near Courtenay, conditional on receiving a time extension for exploration commitments from tenure vendor Weldwood; this program may proceed in 2002 if there is sufficient time prior to the rainy (fall) season; Hillsborough has also announced plans to construct a 49.9 MW coal-fired power plant near the Quinsam Coal Mine.
