## DOUBLESTAR HALTS DRILLING PROGRAM ON CATFACE COPPER

September 26, 2006

VANCOUVER, British Columbia – Doublestar Resources Ltd (DSR-TSXV) has cancelled the exploratory drill program on its Catface copper property on the west coast of Vancouver Island pending an Ahousaht First Nation referendum on the project.

At a meeting held on Monday, September 25th, Ahousaht hereditary chiefs advised that they were opposed to the drill program and objected to the presence of the Company in the village of Ahousaht and on Catface Mountain. The Company had earlier been invited to base the drilling program in Ahousaht, and had arranged employment of seven Ahousaht band members.

Up until yesterday's meeting, the Company has had a cordial relationship with the Ahousaht First Nation, with whom it has been consulting on the project for six years. During that time, hydrological evaluations of the waters draining Catface Mountain have indicated that the geochemical system is alkaline rather than acidic and that there is a low presence of metals in solution in these waters.

The work program was designed as a low-impact, helicopter-mounted program that was, primarily, of a scientific and technical nature while secondarily an exploration program. The program would have enabled the Company to qualify the two principal environmental issues of mining: the tendency of rocks being mined to or not to generate acid and the tendency of rocks being mined to or not to leach metals into solution.

Doublestar holds work permit #MX-8-238 covering 3,000 metres of diamond drilling on the Mining Lease and mineral claims that comprise the project. However, out of respect for the Ahousaht community and people, the Company will await the results of the proposed referendum to be held at their Annual General Meeting tentatively scheduled for November 22 - 24, 2006.

## **Doublestar Resources to Drill Catface Copper Deposit**

Vancouver, British Columbia – Doublestar Resources Ltd (TSX-V:DSR) will commence a diamo drilling program at its Catface porphyry copper property located on Catface Peninsula, 13 km northwof Tofino, on the West Coast of Vancouver Island, in September 2006.

"Our goal with this program is to confirm and better qualify the copper property's historic indicat resource," says Alan Savage, CEO and president of Doublestar. "We strongly believe, however, that t size of the deposit can be expanded with follow-on drilling."

The property contains a historic indicated resource of 169 million tonnes grading 0.43% copper (a 0.30% copper cutoff) and 0.014% molybdenum disulphide (SRK, 1990). Past drilling totals 20,6 metres with the majority of it radiating from an 857 metre adit driven through the core of the deposit.

The program, which has been permitted, is comprised of up to 3,000 metres of NQ diamond drilling in to 10 holes that will be assayed for copper, molybdenum, silver, gold and rhenium. The drilling will all provide material for metallurgical analysis and testing of the environmental geochemistry of the mineralization, waste rock and tailings. The program will include holes to confirm historic drill result to infill between prior drill holes, and to explore un-drilled target areas such as the Hecate Bay anomaly

Doublestar has contracted with Beaupre Diamond Drilling Ltd. to conduct this drilling program from helicopter serviced pads so no road construction or reactivation is needed. The program will be led Paul D. Gray, P.Geo, Vice President, Exploration of Doublestar and the Qualified Person for the program.

A bit of a heads up for you. I was part if a meeting yesterday (with Fred Herman and Norm Marcy) with representatives of the Ahousat Band. They have been approached by Doublestar to investigate the possibility of some sort of partnership or strategic alliance to enable work to restart on the Catface. The band was looking for information about the deposit and also about the process for project review/mine review, possible environmental impacts, etc.

I gave them all the information I could dig up (MINFILE plus the papers in the 2 CIM porphyry volumes) plus I briefly showed them how to access the Map Place, etc. I also mentioned your name as I'm certain that you would have visited the property when it was last active. You can probably expect a call or office visit from Mike Bonshor of Visions First Nations Planning Group. They seem very interested in the economic opportunity that Catface presents, though they quite rightly want to be as aware as possible of the potential pitfalls. We suggested that they might talk to the Tahtlan (Eskay Creek) and other groups that are already involved with mining to get their perspectives. An encouraging sign and a definite plus for Doublestar to start the ball rolling.
